President Jerilyn Hutson called the December meeting to order.

The November minutes were approved. (Wilkerson/Mathews)

Jill Nilsen shared information about the 2<sup>nd</sup> year of 94<sup>th</sup> General Assembly. The Spring Session will reconvene on January 11 and ends on April 7, 2006. Currently tracking 100 bills. Since this is an election year, things will move fairly quickly. Dr. Nilsen indicated there are two bills of great interest to EIU:

Senate Bill 1879 – Ethics and Procurement Bill – has been totally revised and revamped. There are four parts of this bill that affects EIU – Procurement, Ethics, Naming Rights, and Pensions/Retirement. Thought that the “Naming Rights” part of the bill was a dead issue. Language has been modified – any donation over \$25,000 which results in “naming” must be reviewed by the Ethics Commission. Able to exempt “Naming Rights” for a person donating monies. Buildings would be exempt if a plaque was placed on the inside of the building – not as the name of the building. Any corporation wishing to donate monies for a building must go through the Ethics Commission. Athletics will be most heavily impacted.

HB 4166 and SB2151 have both been introduced to reverse a decision in the pension bill. Faculty working 9 months/promotions of any position should be eliminated from the SURS 6% calculation.

Pension Commission Review – recommending no changes – currently 30 years of service, regardless of age and you can retire at full benefits.

Recently attended an Education Summit – Position of University with our students is that we can guarantee you a good job – The University position with our students needs to be we are here for the **public good**.

The university needs to be more vocal and writing our representatives about budgets and plans for EIU.

Legislators think of K-12 instead of higher education.
