Pending Executive Actions:**CAH*****Effective Fall 2005***

1. Eliminate the Minor in Music for Teacher Certification.

Rationale: this is not a viable program. Certification in music requires highly specialized and comprehensive training that can only be achieved according to national, state, and university standards in the course of a four to four-and-a-half year degree program. Moreover, we have not had a student in this program for many years.

AND

2. In the General Music Concentration of the Teacher Certification Option, stipulate that 3 semester hours of the required seven be in MUS 1110 Intermediate Applied Voice.

Rationale: General Music specialists do most of their work in the classroom with the voice; students sing as their primary activity in these classes. Therefore, a certain proficiency in voice is absolutely essential to the competency of the General Music teacher.
