I. Minutes

II. Communication

Dr. Parker and Dr. Stoner presented the proposal and answered questions of the Council. The motion passed unanimously.

MUSIC WITH TEACHER CERTIFICATION OPTION

Standard Special Certificate

This option comprises 21 sh in Music Theory (MUS 1541, 1542, 1543, 1544, 2541, 2542, 2543, 2544, 35 41 or 3542, and 2 sh from 1570, 3547, 3570, 4541, 4542, 4750, 4840, or 4850); 9 sh in Music History (MUS 1581, 3581, and 3582); 3 sh Conducting (MUS 2155 and 3155 or 3156); 2 sh in Keyboard Skills (MUS 2203 /2205 and 2204/2206 or applied piano) Recital 1103 (five semesters), 3100, 4100; 7 sh of Applied lessons (taken over 7 semesters); 7 sh of Ensemble (taken over 7 semesters); and one of the concentrations listed below.

The following courses comprise the PROFESSIONAL EDUCATION CORE required of all music teacher certification majors:

MUS 2440 (1 sh); MUS 2441 (1 sh); MUS 2442 (2 sh) (Vocal & General Music Concentrations only); MUS 3400 (4 sh) (Instrumental Concentration only); MUS 3440 (4 sh) (Vocal & General Music Concentrations only); EDF 2555 (3 sh); EDP 3331 (3 sh); SED 3330 (3 sh); SPE 3500 (3 sh); EDF 4450 (3 sh); STG 4000 (1 sh); STG 4001 (14 sh)

This major requires that students follow and meet the requirements for Admission, Retention and Graduation from Teacher Certification programs as described in the "Teacher Certification Programs" section of this catalog and as explained at the University Admission to Teacher Education Meeting which all students must attend. Students must gain University Approval to Take Teacher Education Courses no later than the end of their first semester Junior year in order to use this suggested plan. Additional information on Admission, Retention and Graduation for Teacher Certification programs can be found on the College of Education & Professional Studies website at www.eiu.edu/ceps/teached.

All students must pass the Illinois Certification Test of Basic Skills for selection into teacher education and should complete this requirement no later than their sophomore year.

Students must receive a "C" or better in all professional education courses and maintain a minimum cumulative and major GPA of 2.65 in order to continue in the program. Courses requiring a "C" or better are identified in the suggested plan by a "+".

A possible 4-year plan of study for the B. M. with Teacher Certification major follows. Other plans are possible and the student should consult with his/her advisor to develop the study plan best suited to his/her needs and interests.

INSTRUMENTAL CONCENTRATION

Music 1302, 1303, 1305, 1306, 2155, 3156, 3400; 3 sh in instrumental or keyboard applied distributed over three semesters; 4 sh in a university instrumental ensemble.

Completion of a teacher certification minor does not guarantee that the individual will be granted an endorsement to teach in that field. Individuals must meet all requirements (including state tests) as set forth by the Illinois State Board of Education to be granted an endorsement in a second teaching field **at the secondary level.**

IV. Election of Officers

Dr. Greenlaw was elected chair and Dr. McNitt was elected vice-chair of COTE for 2003-04 by acclamation.

VI. Executive Director's Report

Dean Rohn recently met with the presidents of nine community colleges. They were extremely complimentary of EIU and of the cooperation between EIU and the community colleges.

The Governor is considering a proposal that calls for the virtual elimination of the Regional Offices of Education and for massive cuts to the Illinois State Board of Education.

There is legislation being considered to eliminate the current Teacher Certification Board and to replace it with a board appointed by the Governor. This is the board that approves and oversees all teacher certification programs.

Dean Rohn also shared handouts regarding the new Assessment of Professional Teaching (APT) exam, the new testing fees, implementation schedule for the new certification tests, and the new content tests to be administered beginning July, 2004.
