Council on Academic Affairs Minutes April 19, 2007

The April 19, 2007 meeting on Council on Academic Affairs was held at 2:05 p.m. in Booth Library Conference Room 4440.

I. Approval of the April 12, 2007 CAA Meeting Minutes.

The minutes of April 12, 2007 were approved as written.

II. Communications:

1. April 11, 2007 memorandum from Dean Hanner, COS, requesting executive action to revise several Biological Sciences course descriptions.
2. April 17, 2007 memorandum from Ms. Fopay about scheduling summer CAA meetings. *Dr. Roszkowski requested that the council members submit their schedules to Ms. Fopay no later than Tuesday, April 24, 2007.*
3. Minutes from the April 6, 2007 College of Sciences Curriculum Committee meeting.

III. Committee Reports:

The CAA Professor Laureate Subcommittee recommended to the council that Dr. Ann Fritz be named as the 2007 Professor Laureate. Ms. Dilworth moved and Dr. Bower seconded to accept this recommendation. The motion passed unanimously.

IV. Items Added to the Agenda:

1. 07-45, Political Science: International Studies Option (Revised Major)
2. 07-46, ACC 3750, Governmental and Nonprofit Accounting (New Course)

Dr. Dietz moved and Ms. Dilworth seconded the motion to add these items to the agenda.

NOTE: The ACC 3750 course proposal was not listed on this week's CAA agenda. It was submitted to CAA after the agenda had been posted. Since there is only one more CAA meeting scheduled for this semester, Dr. Roszkowski asked the council to consider adding the proposal to that meeting agenda so it could be acted upon.

V. Items Acted Upon:

1. **07-41, HIS 3330, Modern East Asia in the Pacific Century (New Course)**
Dr. Lee presented the proposal and answered questions of the council. The council requested revisions. Also, the effective date was changed from Summer 2007 to Summer 2008.

Dr. Hyder moved and Dr. Dietz seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, *effective Summer 2008*.

3330 HIS. Modern East Asia in the Pacific Century (3-0-3) On Demand. Modern East Asia. This course examines the major historical transformation of East Asia from the nineteenth century to the present. Particular attention will be given to the most influential political, economic, and social phenomena that shaped the lives of the people in China, Korea, and Japan in the emergence of the Pacific Century. The course examines their historical relationships both within the region and across the Pacific with the U.S. Course may not be repeated. WI

2. 07-42, HIS 4870, The Two Koreas (New Course)

Dr. Lee presented the proposal and answered questions of the council. The council requested revisions to the proposal.

Dr. Bower moved and Dr. Stowell seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, *effective Spring 2008*, pending CGS approval.

4870 HIS. The Two Koreas. (3-0-3) On Demand. This course examines the historical context in which North and South Korea emerged and continued as a divided nation during the twentieth century. Particular attention will be paid to most important political, economic, and socio-cultural phenomena in the divergence of the images and reality of North and South Korea before, during, and after the national division of 1945. Course may not be repeated. WI

3. 07-43, HIS 4880, Modern Japan: From Samurai to Freeters (New Course)

Dr. Lee presented the proposal and answered questions of the council. The council requested revisions to the proposal.

Dr. Dietz moved and Dr. Feimer seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, *effective Fall 2008*, pending CGS approval.

4880 HIS. Modern Japan: From Samurai to Freeters. (3-0-3) On Demand. Modern Japan. This course examines the historical transformation of Japan from Tokugawa times to the present. Particular attention will be given to the most influential political, economic, and social phenomena that the people have faced in the making of modern Japan since the nineteenth century. Course may not be repeated. WI

4. 07-44, HIS 4980, The Vietnam War: An American and Vietnamese Ordeal (New Course)

Dr. Wehrle presented the proposal and answered questions of the council. The council requested revisions to the proposal.

Mr. Feimer moved and Dr. Stowell seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, *effective Spring 2008*, pending CGS approval.

4980 HIS. The Vietnam War: An American and Vietnamese Ordeal. (3-0-3) On Demand. The Vietnam War. A reading, discussion, and writing course focusing on the Vietnam War (Second Indochinese War, 1965-1975) from an American, Vietnamese, and international perspective. Course may not be repeated. Restriction: Juniors (60 credits or more). WI

VI. Program Review Presentation:

Dr. Wandling and Dr. Anderson presented the B.A. in Political Science program review and answered council members' questions.

Dr. Stowell moved and Ms. Dilworth seconded the motion to accept the presentation.

1. Revise the course description for BIO 1001G.

1001G BIO Biological Principles and Issues. (2-2-3) An introduction to the study of living organisms with emphasis upon an appreciation for their behavioral, functional, and structural adaptations, their diversity and relationship to the environment. In addition, strong emphasis on current issues dealing with the field of biology. Does not count toward the Biological Sciences major or minor. Credit for BIO 1001G will not be granted if the student already has credit for **or registration in BIO 1091G or BIO 1100. L1 900L**

2. Change the course description for BIO 1002G.

1002G BIO Practical Botany. (2-2-3) This course will introduce students to the importance of plants in their daily lives. General botanical principles will be taught with emphasis on instructing students in methods of identification, growth and maintenance of plants used in landscaping, gardening, and interiorscaping. Does not count toward the Biological Sciences major or minor. **Credit for BIO 1002G will not be granted if the student already has credit for or registration in BIO 1092G or BIO 1200G.**

2. Update the course description for BIO 1003G.

1003G BIO Life of Animals. (2-2-3) An introduction to the study of animals and animal diversity with emphasis on behavioral, functional, and structural adaptations as they relate to specific habitats. Does not count toward the Biological Sciences major or minor. **Credit for Bio 1003G will not be granted if the student already has credit for or registration in BIO 1093G or BIO 1300G.**

3. Revise the course description for BIO 1004G.

1004G BIO Practical Microbiology. (2-2-3) Using practical laboratory experiences students learn characteristics and activities of microorganisms with special emphasis on their significance to society. This course targets students majoring in Family and Consumer Sciences, Pre-Nursing, and Health Studies. ~~It is not open to those with credit or registration in BIO 3300.~~ Does not count in the Biological Sciences major or minor. **Credit for BIO 1004G will not be granted if the student already has credit for or registration in BIO 1094G or BIO 3300. L1 903L**

5. Amend the course description for BIO 1091G.

1091G BIO. Biological Principles and Issues, Honors. (2-2-3) The study of the fundamental processes and structures common to all living things. Current issues in the biological sciences will be addressed. **Does not count toward the Biological Sciences major or minor. Credit for BIO 1091G will not be granted if the student already has credit for or registration in BIO 1001G or BIO 1100.** Prerequisites: Admission to the University Honors College. ~~Credit for BIO 1091G will not be granted if the student already has credit for BIO 1001G or BIO 1100.~~ **L1 900L WI**

6. Change the course description for BIO 1092G.

1092G BIO. Practical Botany, Honors. (2-2-3) This course will introduce students to the importance of plants in their daily lives. Emphasis will be placed on students learning methods for the identification, growth and maintenance of plants used in landscaping, gardening and the home. ~~This course d~~ Does not count toward the Biological Sciences major or minor. **Credit for BIO 1092G will not be granted if the student already has credit for or registration in BIO 1002G or BIO 1200G.** Prerequisite: Admission to the University Honors College.

7. Update the course description for BIO 1093G.

1093G BIO Life of Animals, Honors. (2-2-3) An introduction to the study of animals with an emphasis upon an appreciation for their behavioral, functional, and structural adaptations, their diversity and relationships to their environment. **Does not count toward the Biological Sciences major or minor. Credit for BIO 1093G will not be granted if the student already has credit for or registration in BIO 1003G or BIO 1300G.** Prerequisite: Admission to the University Honors College. WI

8. Amend the course description for BIO 1094G.

1094G BIO Practical Microbiology, Honors. (1-4-3) (1-4-3) Using practical laboratory experiences student will learn characteristics and activities of microorganisms with emphasis on the performance of standard procedures and techniques used to study microbes. The course culminates with a student designed original research project. Does not count toward the Biological Sciences major or minor. **Credit for BIO 1094G will not be granted if the student already has credit for or registration in BIO 1004G or BIO 3300.** ~~Not open to students with credit or registration in BIO 3300.~~ Prerequisite: Admission to the University Honors College.

9. Revise the course description for BIO 2001G.

2001G BIO Human Physiology. (3-2-4) An organ systems approach to the function of the human body. Does not count toward the Biological Sciences major or minor. **Credit for BIO 2001G will not be granted if the student already has credit for or registration in BIO 2091G or BIO 3520. L1 904L**

10. Update the course description for BIO 2002G.

2002G BIO Environmental Life Sciences. (3-0-3) A study of the interrelationships of the living and non-living components of the environment, the ecology of humankind, and the interaction of humans with the environment. The course emphasizes current environmental issues and possible solutions and courses of action. Does not count toward the Biological Sciences major or minor. **Credit for BIO 2002G will not be granted if the student already has credit for or registration in BIO 2092G or BIO 3850.**

11. Change the course description for BIO 2003G.

2003G BIO. Heredity and Society. (3-0-3) A course for non-science majors that addresses the ethical, political, and social implications of heredity and modern genetic technology. Basic genetic principles as well as contemporary issues in biotechnology will be studied. Does not count toward the Biological Sciences major or minor. **Not open to those students with credit for, or registration in, BIO 3200. Credit for BIO 2003G will not be granted if the student already has credit for or registration in BIO 2093G or BIO 3200.**

12. Amend the course description for BIO 2091G.

2091G BIO Human Physiology, Honors. (3-2-4) An organ systems approach to the function of the human body. Does not count toward the Biological Sciences major or minor. **Credit for BIO 2091G will not be granted if the student already has credit for or registration in BIO 2001G or BIO 3520.** Prerequisite: Admission to the University Honors College. WI

13. Update the course description for BIO 2092G.

2092G BIO Environmental Life Sciences, Honors. (4-0-4) A study of the interrelationships of the living and non-living components of the environment, the ecology of humankind, and the interaction of humans with the environment. The course emphasizes current environmental issues and possible solutions and courses of action. Does not count toward the Biological Sciences major or minor. **Credit for BIO 2092G will not be granted if the student already has credit for or registration in BIO 2002G or BIO 3850.** Prerequisite: Admission to the University Honors College.

14. Revise the course description for BIO 2093G.

2093G BIO. Heredity and Society, Honors. (4-0-4) A course for non-science majors that addresses the ethical, political, and social implications of heredity and modern genetic technology. Basic genetic principles as well as contemporary issues in biotechnology will be studied. Does not count toward the Biological Sciences major or minor. **Credit for BIO 2093G will not be granted if the student already has credit for or registration in BIO 2003G or BIO 3200. Not open to those students with credit for, or registration in, BIO 3200.** Prerequisites: Admission to the University Honors College. WI
