Ms. Dilworth moved and Dr. Dietz seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, (**See Attachment A**) was approved, *effective Fall 2006*.

2. 06-39, INT 3603, Mechanical Systems in Residential and Commercial Buildings (New Course)

Dr. Toosi and Dr. Wahby presented the proposal and answered questions of the council.

Ms. Dilworth moved and Dr. Roszkowski seconded the motion to approve the proposal. The motion passed unanimously.

The proposal was approved, *effective Spring 2007*. As a result, INT 3803 will be deleted from the catalog.

3603 INT. Mechanical Systems in Residential and Commercial Buildings. (3-0-3) S. Mech Sys Bldgs. Study of principles and standards of mechanical, heating, and air-conditioning systems in construction. The course will concentrate on calculation and selection of pipes, ducts, equipments for water, sewer, ventilation, heating, and air-conditioning of residential and light commercial buildings. Prerequisites: INT 3223 Architectural Drafting and Blueprint Reading and INT 2324 Electronic Control Systems.

3. 06-40, FCS 3755, Nutrition Across the Lifespan (Revised Course)

Dr. Burns presented the proposal and answered questions of the council.

Dr. Roszkowski moved and Dr. Dietz seconded the motion to approve the proposal. The motion passed unanimously.

The proposal was approved, *effective Fall 2006*.

3755 FCS. Nutrition Across the Lifespan. (3-0-3) F. Nutr Lifespan. Concepts of normal human nutrition with emphasis on nutrient needs throughout the lifespan. Prerequisites: FCS 2100, CHM 1410G, CHM 1415G, BIO 2001G. WA

4. 06-41, FCS 4756, Adult Weight Management (New Course)

Agenda item 06-41 was not presented today. It was requested that action on the item be postponed until the April 27, 2006 CAA meeting.

5. 06-42, FCS Merchandising Concentration (Revised Concentration)

Ms. Dilworth presented the proposal and distributed a copy of the rationale for the proposed changes to the FCS Merchandising Concentration. There were no questions.

Dr. Roszkowski moved and Mr. Glenn seconded the motion to approve the proposal. The motion passed unanimously.

The proposal (**See Attachment B**) was approved, *effective Fall 2006*.

6. 06-43, Print and Textile Technologies Interdisciplinary Minor (New Interdisciplinary Minor)

Ms. Dilworth and Dr. Age presented the proposal. There were no questions.

Dr. Roszkowski moved and Mr. Marcy seconded the motion to approve the proposal. The motion passed unanimously.

The proposal (**See Attachment C**) was approved, *effective Fall 2006*.

Dr. Roszkowski distributed a copy of the rationale for the proposed changes to the Computer Information Systems program and courses (agenda items 06-52 thru 06-55). In addition, she submitted a request to add the following statement to the course prerequisites for MIS 3200, 3330, 3515, 3530, 4200, 4330, 4530, 4700, and 4850 (All course proposals to be acted upon today):

“and admission to the School of Business or to a minor offered by the School of Business or permission of the Chair, School of Business.”

NOTE: The course prefixes for courses in the Computer Information Systems program will change from CIS to MIS, effective Fall 2007, pending approval of the proposal (agenda item 06-55) to rename and restructure the major and minor to Management Information Systems.

7. 06-44, MIS 2000, Information Systems & Logic (Revised Course)

Dr. Nantz and Dr. Roszkowski presented the proposal and answered questions of the council. Item 2.e. on the course proposal was revised to read “Not Applicable.”

Mr. Marcy moved and Dr. Roszkowski seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with one revision, was approved, *effective Fall 2007*, pending course fee approval by the President's Council.

2000 MIS. Introduction to Information Systems & Logic. (3-0-3) F, S. IS & Logic.

An introduction to career paths, hardware and software fundamentals, and the tools and methods of formal logic mandatory to produce business application programs. Includes the application of Visual Basic (VB) to illustrate and extend the methodology being presented. Prerequisite: BUS1950 or equivalent.

8. 06-45, MIS 3200, Networking Fundamentals (Revised Course)

Dr. Nantz and Dr. Roszkowski presented the proposal and answered questions of the council. The following statement was added to the course prerequisites: "and admission to the School of Business or to a minor offered by the School of Business or permission of the Chair, School of Business."

Mr. Glenn moved and Dr. Roszkowski seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with one revision, was approved, *effective Fall 2007*, pending course fee approval by the President's Council. ***This course will replace CIS 3200 and CIS 3700.***

3200 MIS. Networking Fundamentals. (3-0-3) (F, S) NETWORK FUND. Study of business telecommunications, teleprocessing, and computer networks. Installing, configuring and administering local area networks. Prerequisites: BUS 1950 and junior standing and admission to the School of Business or to a minor offered by the School of Business or permission of the Chair, School of Business. WA

9. 06-46, MIS 3330, Java Programming (Revised Course)

Dr. Nantz and Dr. Roszkowski presented the proposal and answered questions of the council. The following statement was added to the course prerequisites: "and admission to the School of Business or to a minor offered by the School of Business or permission of the Chair, School of Business."

Dr. Upadhyay moved and Dr. Dietz seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with one revision, was approved, *effective Fall 2007*, pending course fee approval by the President's Council. ***This course will replace CIS 3320 and CIS 3900.***

MIS 3330. Java Programming. (3-0-3) F. Java. A study of object oriented programming using the Java language. Includes program structure, data types, operators, input/output statements, arrays and the Swing components of the graphical interface. Emphasizes the development of objects, including the concepts of polymorphism, encapsulation and inheritance. Prerequisite: MIS 2000 or MAT 2170 and admission to the School of Business or to a minor offered by the School of Business or permission of the Chair, School of Business. WI

10. 06-47, MIS 3515, Information Presentation (Revised Course)

Dr. Nantz and Dr. Roszkowski presented the proposal and answered questions of the council. The following statement was added to the course prerequisites: "and admission to the School of Business or to a minor offered by the School of Business or permission of the Chair, School of Business." Also, the following revisions were requested to 4.C. of the course proposal: Delete the sentence "It is not similar to other courses." and add the sentence "This course is similar to FCS 4926, Public Presentation."

Dr. Dietz moved and Mr. Glenn seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, *effective Fall 2007*, pending course fee approval by the President's Council. ***This course will replace CIS 3510.***

3515 MIS. Information Presentation. (3-0-3) On Demand. INFO PRESENT. The study of design principles for business presentations and documents. Development of illustration skills to effectively use graphics. Photo editing for restoration, enhancement, and creation of digital images. Prerequisites: BUS 1950 and junior standing and admission to the School of Business or to a minor offered by the School of Business or permission of the Chair, School of Business.

11. 06-48, MIS 3530, Business Web Site Design (Revised Course)

Dr. Nantz and Dr. Roszkowski presented the proposal and answered questions of the council. The following statement was added to the course prerequisites: "and admission to the School of Business or to a minor offered by the School of Business or permission of the Chair, School of Business." Also, the following revisions were requested to 4.C. of the course proposal: Delete the sentence "It is not similar to other courses." and add the sentence "This course is similar to INT 1363, 3343, 4353, and 4813."

Mr. Marcy moved and Ms. Frederick seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, *effective Fall 2007*, pending course fee approval by the President's Council. ***This course will replace CIS 3530.***

3530 MIS. Business Web Site Design. (3-0-3) F. BUS WEB SITE DSN. Fundamentals of designing effective web sites including graphics and animation using web application software. Some HTML and JavaScript will be introduced. Students will develop web sites with a focus on information architecture and usability standards for business web sites. Prerequisites: BUS 1950 and junior standing and admission to the School of Business or to a minor offered by the School of Business or permission of the Chair, School of Business. WI

12. 06-49, MIS 4200, Systems and Database Analysis, Design, and Development (New Course)

Dr. Nantz and Dr. Roszkowski presented the proposal and answered questions of the council. The following statement was added to the course prerequisites: "and admission to the School of Business or to a minor offered by the School of Business or permission of the Chair, School of Business."

Mr. Marcy moved and Mr. Glenn seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with one revision, was approved, *effective Fall 2007*, pending course fee approval by the President's Council. ***This course will replace CIS 3000 and CIS 4000.***

MIS 4200. Systems and Database Analysis, Design, and Development. (4-0-4) F, S. Sys DB Des Dev. A study of the systems development life cycle and relational and object-oriented databases. Includes the use of CASE tools and client/server database software prerequisites: MIS 2000 and either BUS 3500 or ACC 3900 and admission to the School of Business or to a minor offered by the School of Business or permission of the Chair, School of Business.

13. 06-50, MIS 4300, File Organization with COBOL (Revised Course)

Dr. Nantz and Dr. Roszkowski presented the proposal. There were no questions.

Mr. Marcy moved and Dr. Dietz seconded the motion to approve the proposal. The motion passed unanimously.

The proposal was approved, *effective Fall 2007*, pending course fee approval by the President's Council. ***This course will replace CIS 3340.***

MIS 4300. File Organization with COBOL. (3-0-3) F. FileOrg-COBOL. A study of disk file structures, organization and file management methods. Advanced COBOL concepts are used in a file-processing environment. Emphasis on indexed file structures, and sequential, random, and dynamic access methods by both primary and alternate keys. Includes disk file organization, creation, storage, retrieval, maintenance and security, system integration testing, to include writing test plans, executing test cases and tracking defects. Prerequisites: MIS 3300, junior standing, or permission of chair

14. 06-51, MIS 4330, Advanced Java Programming (Revised Course)

Dr. Nantz and Dr. Roszkowski presented the proposal and answered questions of the council. The following statement was added to the course prerequisites: "and admission to the School of Business or to a minor offered by the School of Business or permission of the Chair, School of Business."

Mr. Glenn moved and Ms. Frederick seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with one revision, was approved, *effective Spring 2008*, pending course fee approval by the President's Council. ***This course will replace CIS 3900 and CIS 4330.***

4330 MIS Advanced Java Programming. (3-0-3) S. Adv Java. A study of the object paradigm with emphasis on graphics development, gaming theory and design, threads, database retrieval and update, applets, packages, and security in the java language. Prerequisite: MIS 3330 and admission to the School of Business or to a minor offered by the School of Business or permission of the Chair, School of Business.

15. 06-52, MIS 4530, Web Application Development (New Course)

Dr. Nantz and Dr. Roszkowski presented the proposal and answered questions of the council. Dr. Age and Ms. Dilworth indicated that this course is similar to other courses. However, the course proposal states that there is no similarity with any existing course at the University.

Dr. Roszkowski moved and Ms. Frederick seconded the motion to send this course proposal back to the LCBAS College Curriculum Committee to resolve the issue as to whether or not this course is similar to other courses.

The motion passed with the following vote.

16. 06-53, MIS 4700, Advanced Networking (Revised Course)

Dr. Nantz and Dr. Roszkowski presented the proposal and answered questions of the council. The following statement was added to the course prerequisites: "and admission to the School of Business or to a minor offered by the School of Business or permission of the Chair, School of Business."

Mr. Glenn moved and Ms. Dilworth seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with one revision, was approved, *effective Spring 2008*. **This course will replace CIS 4700.**

4700 MIS. Advanced Networking. (3-0-3) S. ADV NETWORKING. Internetworking concepts, advanced internetwork design, security, and administration. Enterprise network design, management and user administration. WAN data analysis and troubleshooting. Prerequisite: MIS 3200 and admission to the School of Business or to a minor offered by the School of Business or permission of the Chair, School of Business.

17. 06-54, MIS 4850, Systems Security (New Course)

Dr. Nantz and Dr. Roszkowski presented the proposal and answered questions of the council. The following statement was added to the course prerequisites: "and admission to the School of Business or to a minor offered by the School of Business or permission of the Chair, School of Business."

Dr. French and Mr. Glenn seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with one revision, was approved, *effective Fall 2007*.

MIS 4850. Systems Security (3-0-3) F. SYS SECURITY. Study of theories, principles and techniques of systems security. The course covers basic security concepts, communications security, infrastructure security, cryptography, as well as operational and organizational security. Prerequisite: BUS 3500 or ACC 3900, and admission to the School of Business or to a minor offered by the School of Business or permission of the Chair, School of Business. WA

18. 06-55, Management Information Systems (Proposal to Rename & Restructure the Computer Information Systems Major and Minor)

Agenda item 06-55 was not presented today. Action on the proposal was postponed until after the LCBAS Curriculum Committee has resolved the issue with agenda item 06-52 (Course proposal for MIS 4530, Web Application Development).

2. Rename the title for CMN 4800.

4800 CMN ~~Contemporary American Public Address.~~ Voices of Democracy. (3-0-3) On Demand. Study of competing points of view on a series of critical issues of the Twentieth Century. WI
