### Council on Academic Affairs Minutes

April 15, 2004

The April 15, 2004 meeting of the Council on Academic Affairs was held at 2:00 p.m. in Booth Library Conference Room 4440.

**Members present:** Mr. Collier, Ms. Dilworth, Mr. Donash, Dr. Fewell, Dr. Helsel, Dr. Reid, Ms. Samuels, Ms. Sartore, Ms. Sterling, and Dr. Tidwell.

**Guests present:** Dr. Bates, Health Studies; Ms. Creath, Records Office; Ms. Miller, Student Senate; and Ms. Peryam, *Daily Eastern News*.

#### I. Minutes

The minutes of April 8, 2004 were approved as written.

#### II. Communications:

1. Minutes from the March 31, 2004 and April 7, 2004 Arts and Humanities Curriculum Committee meetings.
2. April 6, 2004 memorandum from Dean Hoadley, LCBAS, requesting executive actions to change the prerequisites for MAR 3550 and to delete BIO 1004 as a program requirement for BS in Family and Consumer Sciences: Dietetics Option, effective Fall 2004.
3. Academic Waiver Report for March 2004 from the College of Education & Professional Studies.

#### III. Committee Reports:

1. The CAA Faculty Laureate Subcommittee recommended to the council that Dr. Nancy Marlow be named as the 2004 Professor Laureate. Dr. Dietz moved and Dr. Dilworth seconded to accept this recommendation. The motion passed unanimously.
2. Dr. Tidwell announced that there had been a mistake with the CAA election. Apparently, Dr. Reid's name had been placed on the election ballot by mistake. Dr. Reid explained that when she discovered the error during the first day of elections, she promptly informed the Faculty Senate Elections Committee. As a result, the committee took immediate action to correct the error. Although Dr. Reid's name remained on the ballot during the first day of elections, it was blocked out on the second day.

As a follow-up, Dr. Reid explained that she submitted a communication item to Faculty Senate requesting that the group review the votes and determine whether to accept the results from the CAA race. According to Dr. Tidwell and Dr. Reid, the Faculty Senate members discussed this issue at the April 13 Faculty Senate meeting and determined that the votes should be certified.

CAA members agreed with Faculty Senate's action to certify the votes.

Dr. Tidwell announced that the new CAA members for Fall 2004 will be Dr. David Carwell, Dr. Shelley French, and Dr. Upadhyay.

3. According to Dr. Reid, the Textbook Rental Service committee met on April 13, 2004. She reported that the committee approved an increase in the late fine charged to undergraduate students returning their books late. The fee was increased to ten dollars. Also, she indicated that the committee recommended that the Textbook Rental Service Internal Governing Policy #49 include a more flexible process to propose policy changes. As is, changes can only be made every three years when the policy comes up for review.

Finally, Dr. Reid said that there has been continual work on the Textbook Rental Service online inventory.

**Effective Summer 2004**

1. Change the prerequisites for **SPC/JOU 3610**.

**3610 SPC/JOU. Broadcast News Writing. (2-2-3) On Demand.** Emphasis will be placed upon fitting news copy and coverage to station requirements and audience needs in varying market situations. This course will include news gathering, analysis, editing, and rewriting of wire service copy for broadcasting. Prerequisite: ~~SPC 2520~~ ~~JOU or 3000 or a minimum grade of "C" in~~ JOU 2101 or SPC 2575, or permission of instructor. Credit not granted for both JOU 3610 and SPC 3610. WI

1. Amend the prerequisites for **SPC/JOU 3620**.

**3620 SPC/JOU (2-2-3) On Demand.** A study of the electronic news gathering process, editing, presentation and evaluation for radio and television. Creation of special programs for WEIU. Prerequisite: ~~SPC 2520 or JOU 2101; two of SPC 3520, 3540, 3610~~ SPC/JOU 3610 or permission of instructor. Credit not granted for both JOU 3620 and ~~Speech Communication~~ SPC 3620.

2. Delete references to the Electronic Journalism and Communication Interdisciplinary Concentration from the Undergraduate Catalog. *Note: This concentration appears on page 110 of the 2003-04 Undergraduate Catalog.*

**COS****Effective Summer 2004**

1. **BIO 3450** – Change the grading option from graded (A-F) to “Credit/No Credit”.

**3450 BIO. Independent Study. (Arr.-Arr.-1-3) On Demand. (Credit/No Credit)**

Individual study on a topic in biology selected by the student under the supervision of an instructor. Prerequisites: BIO 1100, 1200G, 1300G and permission of the department chairperson and instructor. May be repeated for credit to a maximum of three semester hours. This course is not intended for students who wish to complete a research project.

2. **BIO 3451** – Change the grading option from graded (A-F) to “Credit/No Credit”.

**3451 BIO. Undergraduate Research. (Arr.-Arr.-1-3) On Demand. (Credit/No Credit)**

Original research in Biological Sciences conducted in consultation with a faculty mentor. Students will conduct a research project using current scientific protocols. Hypothesis formation, bench work, data collection/analysis become the responsibility of each student. Written report required. May be repeated for credit to a maximum of three semester hours. Prerequisites: Sophomore standing and approval of instructor and the department chairperson.

**COS****Effective Fall 2004**

1. **ECN 4689** – Change the course offering from “S” to no designation.

**4689 ECN. Theory and Research. (3-0-3) S-** A capstone course to apply theory in undergraduate research. A written report, oral presentation, and external field examination are required. Prerequisites: This capstone course is intended for Economics majors to be taken in the last semester before graduation and requires permission of the instructor. WI

**LCBAS****Effective Fall 2004**

1. **FCS 4751** – Delete FCS 3151 from the prerequisites.

**4751 FCS. Nutrition Therapy. (4-0-4) F.** Application of the science of nutrition to the maintenance of optimum health and the role of nutrition in the prevention and treatment of disease. Prerequisites: CHM 2430/2335, FCS 2100, **FCS 3151**, and FCS 3755.

2. Include the course titles with the course numbers under the **BS in Industrial Technology Program Concentrations.**

### Digital Printing, Imaging, and Web Technology Technical Concentration

A minimum of 15 semester hours of course work may include study in the areas of digital printing, imaging, web technology, ~~photography, and multimedia.~~ This concentration is designed to provide students with the knowledge and skills necessary to function in the printing and publishing industries, and in imaging and web technology careers. ~~Concentration courses are: INT 1363, 3123, 3343, 3353, 4123, 4813. (Note: INT 1363 and INT 3343 are required courses in the Advertising Interdisciplinary Minor and 6 hrs. of INT 3123, 3353, or 4813 may also count toward that minor).~~ Coursework does include photography, digital printing, multimedia and web technology as listed below:

### Production Technical Concentration

A minimum of 15 semester hours of course work may include study in the areas of metrology, drafting and design, CAD, CNC, metallurgy, casting, machining technology, fabrication, material handling, robotics, and automation. The concentration must include a minimum of six hours of course work related to industrial processes. ~~Concentration courses are: INT 3012, 3063, 3103, 3113\*, 3143\*, 3203\*, 4023, 4274, 4602\*, 4673, 4803, 4853\* (\*denotes an industrial processes course)~~

1. Revise the prerequisites to **MAR 3550**.

**3550 MAR. Marketing as a Profession. (1-0-1) F, S.** This course introduces the student to the marketing profession. Designed as the introductory course to the marketing major, it will allow the student to review important concepts and terms as well as acquaint the student with the expectations of the business world for the professional marketer. Prerequisite: **BUS 3470**, *Junior standing*, admission to the School of Business or permission of Associate Chair.

2. Delete BIO 1004, Practical Microbiology, as a program requirement for B.S in Family and Consumer Sciences: Dietetics Option.

### **DIETETICS OPTION**
