- I. Angie Campbell, President, called the meeting to order at 8:40 am.
- II. Guest Speaker (Nilsen)
  - a. State of Illinois budget is not totally finalized. The session is not quite finished.
  - b. The appropriated funds for next year are just like FY09.
  - c. The funding for the Monetary Assistance Program (MAP) is being cut 83%. This could affect a students' decision to attend EIU. Will know more after school starts in the fall.
  - d. Not a difference in the pensions this year. May see a change in health care for retirees; however the task force is looking into this and will speak to the governor.
  - e. Continuing to watch the ethics bills.
  - f. Veto session is one month earlier this fall; dates are Oct 14-16, and 28-30<sup>th</sup>.
  - g. Harper bill did not pass. This bill would allow community colleges to provide a 4 yr. degree.
- IV. Guest Speaker (Baharlou)
  - a. Provided the Council with a handout in regards to public pensions and explained how Eastern Illinois University's pension plan works.
  - b. You do not have to be retired to join the Annuitants Association.

- V. Guest Speaker (Weber)
  - a. ITS is being restructured.
    1. Mr. McCann and Mr. Chatterji will be providing a restructuring plan.
    2. The restructuring criteria have not changed. The plan will reshape to meet current and future needs. Some positions will be eliminated and some may be created.
  - b. The Illinois bond rating is on the watch list.
  - c. Student numbers look like they are holding okay. Numbers appear to be same as last year.
  - d. The state will fund EIU at the FY09 level.
- VI. Guest Speaker (Leonard/Wayland)
  - a. Parking increases to \$70 for non-negotiated staff members.
  - b. All non-negotiated employees received a pay increase this year.
  - c. Parking fines will increase this year.
- VII. Guest Speaker (Benedict)

There are three years left on the Test Pilot Program. Sandy Bowman is on the committee.
