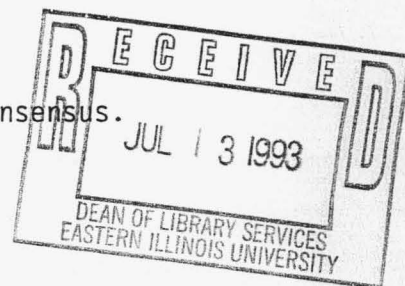
Minutes of the College of Education Curriculum Committee

Item 93-8 - Proposed Changes in Concentrations

Middle School Option  
Jr. High School Fields



Dr. Helwig, Chair of the Department of Elementary & Jr. High School Education, presented suggested changes to address citations from the Illinois State Board of Education report. Areas of Concentration must be in one discipline and require 18 s.h., 9 of which must be upper division courses. In addition, certification changes for Fields I and II have required adjustments for the Jr. High School major. M. McDaniel and C. Helwig are presently working on catalog copy. J. Lambert/S. Garner moved to place this Item on the agenda for action at the next meeting. The motion was unanimously approved.

Item 93-9 - Revision of Student Teaching 4000 description and title - from 'Orientation to Student Teaching' to 'Multicultural Disabilities Practicum'. F. Summers/S. Garner moved to place this Item on the agenda for future action. The motion carried unanimously.
