Butler from the School of Technology as well as Dr. Lucy Campanis, from Family and Consumer Science will serve as faculty assigned to the Career and Technical Education Program.

Passage Rate on Illinois Teacher Certificate Exam

The Career and Technical Education faculty are pleased to announce that 100 percent of the students who took the Illinois Teacher Certification during the academic year of 1999-2000 passed. The State average for passing the exam in the CTE disciplines is 98%.

School of Technology Alumnus and an Advisory Board Member Honored for Accomplishments

CHARLESTON—Eastern Illinois University's Alumni Association, honored six of its alumni for outstanding accomplishments as part of Homecoming activities during the fall 2000 semester. One of those graduates is an alumnus of the School of Technology. Rep. Joe Knollenberg received his bachelor of science in technology education from Eastern in 1955. Knollenberg serves as the U. S. Representative from Michigan's 11th Congressional District. Knollenberg, currently serving his fourth term, has earned the reputation of being a fiscal conservative, an ardent tax cutter and an advocate for policies that strengthen the country's economy and national defense.

New Programs in the School of Technology...

Certificate Programs Offered in School of Technology

As a major effort to help Illinois business and industry sustain economic growth, the School of Technology developed the following graduate certificate programs to meet the focused needs of students and working professionals in industry, business, education and government agencies.

Quality Systems: This 12-hour certificate program is designed to provide students and professionals working in industry and business with focused course work leading to improvement in the quality of products and services. An effective quality system will help organizations become more profitable and more competitive in the global market.

The certificate program in quality systems requires nine (9) credit hours of course work in statistical quality assurance, total quality systems, design for quality, and three (3) hours of electives related to problem solving, reliability engineering, quality system standards, manufacturing and quality management.

Work Performance Improvement: This 15-hour certificate program is designed to meet the needs of graduate students as well as training and development practitioners in the field of work performance improvement. The certificate will signify that recipients possess the knowledge and skills needed for performance consulting and training. It will also make them more marketable to potential employers in the area of training and development.

The certificate program in work performance improvement requires 12 credit hours of course work in training program development, science and technology of leadership, work performance technology, and instructional technology. Three (3) credit hours of electives will be from such areas as

sociotechnical design, facilitation dynamics, critical thinking in work place, productive work teams or accelerated learning and training.

Computer Technology: The 15 hour certificate program is designed to provide graduate students and professionals working in various organizations with course work focused on current state-of-the-art computer technology. Key areas include data communications and networking technology, database technology, multimedia and web technology, management of computer technology, and applications of computer technology. Those areas were identified by employers as the most demanded skills in the new Internet economy.

The certificate program in computer technology requires 12 credit hours of course work in networking and advanced data communications, advanced database technology, multimedia and web technology and management of computer technology. Three (3) hours of electives will be from advanced desktop publishing, instructional technology, advanced computer integrated manufacturing, industrial systems simulation, data acquisition and data communication, (computer) automatic identifications, microcomputer interfacing, control systems, and data acquisition.

Many of these courses are offered through on-campus or off-campus sites close to where students live, or online via Internet.

Two New Faculty Join the School of Technology



Dr. Sam Guccione

Dr. Guccione is a native of Illinois - born and raised in Madison County. He received his B.S. and M.S. in Electrical Engineering from the University of Illinois. Dr. Guccione worked for Douglas Aircraft in California and McDonnell Aircraft in St. Louis before they merged. He was a spacecraft engineer during that time working on the Saturn Booster Rocket and the Gemini Spacecraft. He also spent some time working at Magnavox, in Urbana, doing spy electronics work and then moved on to work at the Annapolis Naval Station, across from the Naval Academy. His primary work for the Naval Station involved electromagnetic compatibility of many different types of radio equipment on airplanes, ships, and ground based. In 1974, he took a job as a Department Chair of Electronics at Delaware Technical & Community College in Dover, Delaware. While at DTCC, he completed his doctorate in education at Temple University in Philadelphia. His specialties include electronics, data communications and computer networking, and wireless communications.

Dr. Age joined the School of Technology this fall as a graphic communication instructor. Age graduated with his B.S. and M.S. from California State University at Long Beach in graphic communications and his doctorate from Illinois State University. He moved to

San Diego and worked on textbooks and magazines for publishers as an imaging output specialist in a prepress firm. The State of California awarded him the “model graphic communications program” while teaching for 11 years at San Dieguito High School, in Encinitas.
