V. Items Acted Upon:

1. 11-27, MUS 1300, Instrumental Methods Lab (New Course).

Dr. Larson presented the proposal and answered questions of the council. The council requested revisions to Part II, 1 of the proposal.

Dr. Klarup moved and Dr. Lucas seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, *effective Fall 2011*.

MUS 1300. Instrumental Methods Lab. (0-2-1) F, S. The course will focus on teaching experience in a beginning/middle school level band setting. Students will gain significant playing time on secondary instruments and will become familiar with materials, literature, conducting techniques, and teaching strategies appropriate for beginning wind players. Students will also complete two hours of clinical observation. This course is restricted to Music majors in the teacher certification option. Course may be repeated to a maximum of 2 hours or 2 times.

2. **11-28, MUS 2071, Music Technology II: Audio and Recording Techniques (New Course).**

Mr. Rubel presented the proposal and answered questions of the council.

Dr. Sterling moved and Dr. Mitchell seconded the motion to approve the proposal. The motion passed unanimously.

The proposal was approved, *effective Fall 2011*.

MUS 2071. Music Technology II: Audio and Recording Techniques. (3-2-3) F. Audio and Recording Techniques. Introduction to the processes, tools and techniques of audio engineering, with an emphasis on music recording. Students will learn from lectures, demonstrations, reading and research, hands-on projects, assisting with recordings and live sound, and field trips. Prerequisite: MUS 1070.

3. **11-29, Music with Performance Option (Revised Option).**

Mr. Daniels presented the proposal and answered questions of the council.

Ms. Green moved and Dr. White seconded the motion to approve the proposal. The motion passed unanimously.

The proposal (**See Attachment A**) was approved, *effective Fall 2011*.

4. **11-43, OPD 3000, Learning Analysis Through Portfolio Development (New Course).**

Dr. Wyatt and Dr. Hawkins presented the proposal and answered questions of the council. The council requested that the Part IV header be placed behind the course outline in the proposal.

Ms. Green moved and Dr. Klarup seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, *effective Fall 2011*. As a result, OPD 1000 will be deleted.

OPD 3000. Learning Analysis Through Portfolio Development. (3-0-3) On Demand. Learning Analysis. This course is designed to enable Organizational & Professional Development majors to understand how to assess and document workplace experiential learning for college-level learning. This highly experiential course emphasizes the identification and development of skills as well as the conceptual frameworks needed to write the portfolio. This course is restricted to Organizational & Professional Development students.

5. **11-44, OPD 4700, Leadership in Organizations (New Course).**

Dr. Hawkins presented the proposal and answered questions of the council. The council requested revisions to Part IV, 3 of the proposal explaining that there is some course overlap with CMN 2650, 3650, and 4650.

Dr. Klarup moved and Ms. Green seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, *effective Fall 2011*.

OPD 4700. Leadership in Organizations. (3-0-3) On Demand. This course covers leadership concepts and theories at the individual and organizational levels. Students will apply these concepts and theories to examine their own leadership practices in organizations through completion of self-assessments, experiential exercises, and participation in team projects.

6. **11-45, OPD 4865, Diversity in Organizations (New Course).**

Dr. Hawkins presented the proposal and answered questions of the council. The council requested that information be added to Part II, 1, b of the proposal.

Dr. Hoerschelmann moved and Dr. Lucas seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, effective Fall 2011, *pending CGS approval*.

OPD 4865. Diversity in Organizations. (3-0-3) On Demand. The study of the differences between employees' cultural values and how these differences affect the work environment. This course will help in developing potential skills to analyze and improve an organization's performance in managing diversity.

7. **11-30, AFR 2000G, African American Social Movements (Revised Course).**

Dr. Ochwa-Echel and Dr. Poulter presented the proposal and answered questions of the council.

Dr. Lucas moved and Ms. Green seconded the motion to approve the proposal. The motion passed unanimously.

The proposal was approved, *effective Fall 2011*.

AFR 2000G. African American Social Movements. (3-0-3) F, S. AFR American Social Movements. This course explores the history of African American social movements. Themes include identity, recruitment, mobilization, tactics, organization, race, gender, alliances, challenges and ideology. WI

8. **11-31, AFR 2200G, Pan Africanism (New Course).**

Dr. Ochwa-Echel and Dr. Poulter presented the proposal and answered questions of the council.

Dr. Mitchell moved and Dr. Klarup seconded the motion to approve the proposal. The motion passed unanimously.

The proposal was approved, *effective Fall 2011*.

NOTE: AFR 2200G will be placed under the Humanities designation within the Humanities and Fines Arts segment of General Education. Also, the course will be designated as a cultural diversity course.

AFR 2200G. Pan Africanism. (3-0-3) F, S. This course examines the political, social, economic, cultural and ideological connections and relationships between Africans and their descendants in the diaspora (Asia, Europe, South America, North America, and the Caribbean) from a historical and comparative perspective. Topics include slavery, colonialism, resistance, Pan Africanism, liberation and black power movements. WI

9. **11-32, AFR 2400, Black Women in the Diaspora (New Course).**

Dr. Ochwa-Echel and Dr. Poulter presented the proposal and answered questions of the council. The council requested revisions to Part I, 9 of the proposal.

Dr. Sterling moved and Ms. Green seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, *effective Spring 2012*.

AFR 2400. Black Women in the Diaspora. (3-0-3) S. This course explores realities of black women in the diaspora with an emphasis on the United States, Canada, Britain, Africa and the Caribbean. Topics such as identity, family, work, slavery, colonialism and globalization will be examined. Strategies that black women have employed to ensure the survival of "Self" and community will be explored. Prerequisites: Students will be required to take AFR 1000G or AFR 2000G before taking this course. WI

10. 11-33, AFR 2500, Introduction to Research Methods in Africana Studies (New Course).

Dr. Ochwa-Echel and Dr. Poulter presented the proposal and answered questions of the council. The council requested revisions to Part 1, 11; Part II, 2; and Part III, Week 12 of the course proposal.

Dr. Hoerschelmann moved and Dr. Klarup seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, *effective Fall 2011*.

AFR 2500. Introduction to Research Methods in Africana Studies. (3-0-3) F. Intro to Research Methods. This course is designed to introduce students to research methods. Students will learn qualitative and quantitative methods of carrying out Africana studies research, how to use scholarly literature to support their analysis and how to write research papers. The following topics will be explored: research ethics, social theory, research design, ethnography, oral history, survey and secondary data analysis. Prerequisites: Students will be required to take ENG 1001G or ENG 1002G or equivalent before taking this course. WI

11. 11-34, AFR 2600, African American Men (New Course).

Dr. Ochwa-Echel and Dr. Poulter presented the proposal and answered questions of the council. The council requested revisions to Part 1, 9; Part II, 2; and Part IV, 4a of the proposal.

Ms. Green moved and Dr. Klarup seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, *effective Fall 2011*.

AFR 2600. African American Men. (3-0-3) F. This course acknowledges the realities that are specific to African American males. Strategies and habits of mind that may reinforce and affirm their cultural strengths and overall identity, particularly in support of academic achievement will be examined. Prerequisite: Students will be required to take AFR 1000G or AFR 2000G before taking this course. WI

12. 11-35, AFR 3150, Women and Development in Africa (New Course).

Dr. Ochwa-Echel and Dr. Poulter presented the proposal and answered questions of the council. The council requested revisions to Part I, 9 of the proposal.

Ms. Green moved and Ms. Ruholl seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, *effective Spring 2012*.

AFR 3150. Women and Development in Africa. (3-0-3) S. Women/Development in Africa. This course will expose students to the existing paradigms on women within Africa. Factors and forces mitigating for and against women such as colonialism, capitalism, patriarchy, religion, education and culture will be explored. Challenges and tasks women face in the process of industrialization and modernization will be assessed and analyzed. Prerequisite: Students will be required to take AFR 2500 or equivalent before taking this course. WI

13. 11-36, AFR 3500, The African American Intellectual Tradition (New Course).

Dr. Ochwa-Echel and Dr. Poulter presented the proposal and answered questions of the council. The council requested revisions to Part I, 9 of the proposal.

Dr. Hoerschelmann moved and Dr. Klarup seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, *effective Spring 2012*.

AFR 3500. The African American Intellectual Tradition. (3-0-3) S. AFR Intellectual Tradition.

This course will adhere to the definition of intellectual history as “the history not of thought, but of people thinking.” Students will explore the critical role that African American intellectuals in all their guises have played in the shaping of the American historical and intellectual landscape. Topics include intellectual responses to slavery, emancipation, nation building and the civil rights movement. Prerequisite: Students will be required to take AFR 2500 or equivalent before taking this course. WI

14. 11-37, AFR 3600, HIV/AIDS and Development in Africa (New Course).

Dr. Ochwa-Echel and Dr. Poulter presented the proposal and answered questions of the council. The council requested revisions to Part I, 9 of the proposal.

Ms. Ruholl moved and Ms. Green seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, *effective Spring 2012*.

AFR 3600. HIV/AIDS and Development in Africa. (3-0-3) S. HIV/AIDS and Dev in Africa.

The main focus in this course is to examine the challenges HIV/AIDS present in Sub Saharan Africa in terms of economic, health, social and demographic underpinnings of development. Though focused on Sub-Saharan Africa as a region, the course will provide students with the building blocks necessary to design an HIV/AIDS prevention campaign and service learning opportunities. Prerequisite: Students will be required to take AFR 2500 or equivalent before taking this class. WI

15. 11-38, AFR 3700, Race and Neighborhood Development (New Course).

Dr. Ochwa-Echel and Dr. Poulter presented the proposal and answered questions of the council. The council requested revisions to Part I, 9 of the proposal.

Ms. Green moved and Dr. Mitchell seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, *effective Spring 2013*.

AFR 3700. Race and Neighborhood Development. (3-0-3) S. Race and Neighborhood Dev.

The course examines the political causes and consequences of place-based racial inequalities in American cities. The ultimate purpose is to help students understand the legacy of uneven urban development; recognize its contemporary manifestations and ways of challenging it. Prerequisite: Students will be required to take AFR 2500 or equivalent before taking this course. WI

16. 11-39, AFR 4300, Capstone Seminar (New Course).

Dr. Ochwa-Echel and Dr. Poulter presented the proposal and answered questions of the council. The council requested revisions to Part I, 8b, 8c, 8f, 8g, and 11; and Part IV, 2 and 3b of the proposal. Also, the initial term of offering was changed from Spring 2015 to Spring 2013.

Dr. Lucas moved and Dr. Hoerschelmann seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, *effective Spring 2013*.

AFR 4300. Capstone Seminar. (3-0-3) S. This course is designed for senior students who are majors or minors in Africana Studies. Students will apply all the interdisciplinary knowledge they have gained as they design the capstone project. Each student will choose a topic for research, based on his/her area of concentration in the major or minor. The themes of the capstone will be determined by the research interests of the class. This course is restricted to Africana Studies majors and minors. Prerequisites: Completion of 75 hours, AFR 2500 or equivalent, and Africana Studies core courses (Majors: AFR 1000G, 2000G, 2200G, 2500, 3500, and HIS 3750; Minors: AFR 1000G or 2000G, and AFR 2500) or permission from the Director of Africana Studies. WI

17. 11-40, African-American Studies (Proposal to change the program name, curriculum, and degree title).

Dr. Ochwa-Echel and Dr. Poulter presented the proposal and answered questions of the council.

Ms. Green moved and Dr. Sterling seconded the motion to approve the proposal. The motion passed unanimously.

The proposal was approved, *effective Fall 2011*.

The program name will change:

From: African-American Studies
To: Africana Studies

The degree title will change:

From: B.S. in African-American Studies
To: B.S. in Africana Studies

18. 11-41, African-American Studies (Revised Major).

Dr. Ochwa-Echel and Dr. Poulter presented the proposal and answered questions of the council. The council requested revisions to the proposal.

Effective Fall 2011

1. Revise the course description of PLS 2513.

PLS 2513 - Moot Court.

(1-Arr-1) F, S. A role-playing simulation in which students represent attorneys in simulated appellate court competitions. Students will attend at least one competition per semester of enrollment as determined by the instructor, with learning activities ranging from oral arguments to the preparation of written legal briefs. The course may be repeated for a total of six semester hours, but no more than ~~two~~ **three** semester hours may count toward the Political Science major or the Political Science minor. Students may pay expenses associated with registration, travel, room and meal charges while attending competition. Prerequisites and Notes: Restricted to students selected to represent EIU at the moot court competitions designated by the department; completion of the fall semester course or permission of instructor is required for registration in the spring semester course. Credits: 1

2. Change the course description of PLS 2611.

PLS 2611 - Model Illinois Government.

(1-0-1) S. (Credit/No Credit) This course is designed to prepare students for the Model Illinois Government simulation held in Springfield. At the simulation, students take a hands-on approach to understanding the legal authority, structure, functions and processes of the state legislature in Illinois. The course may be repeated for a total of three semester hours, but no more than two semester hours may count toward the Political Science major or the Political Science minor. Students may pay expenses associated with registration, travel, room and meal charges while attending the simulation. Prerequisites and Notes: Restricted to students selected to represent EIU at the simulation. Credits: 1

AET 4673 - Work Measurement and Method Design.

(3-0-3) S. Principles of motion and time study and methods engineering for the purpose of increasing productivity and reducing human effort. Special emphasis will be given to design and measurement of work in industrial environments. Prerequisites and Notes: **AET 1323** and MAT 2120G or 1441G. Credits: 3

2. Change the prerequisites of AET 4843.

AET 4843 - Statistical Quality Assurance.

(3-0-3) F, S. Principles of total quality control; Shewhart control charts; acceptance sampling; capability and reliability studies. Prerequisites and Notes: ~~MAT 1271 or its equivalent.~~ **AET 1323 and BUS 2810 or MAT 2250G.** Credits: 3

3. Revise the prerequisites of AET 4943.

AET 4943 - Manufacturing Management.

(3-0-3) F, S. Survey of technical management areas in a manufacturing operation.
