### V. Items to be Acted Upon

#### 1. **09-01, Policy on Repeating Undergraduate Professional Education Courses with Field Experiences/Practica**

Dr. Bower presented this proposal and answered questions of the Council. Dr. Edwards moved and Dr. Dale seconded the motion to approve this proposal. The motion passed unanimously.

The item was approved, effective Fall 2009, and the following language will be added to the Undergraduate Catalog (in the College of Education & Professional Studies section under Teacher Certification Programs) and in the Academic Handbook guide (under Special Programs):

#### Repeating Undergraduate Professional Education Courses with Field Experiences/Practica

Students may **enroll** in any undergraduate professional education course that includes a field experience or practicum **no more than twice**. Any students wishing to attempt a field experience/practicum course more than twice must appeal to the department in which the course is offered. The department will review the request and make a determination as to re-enrollment in the course. If the request is approved, a remediation plan must be developed and completed prior to re-enrollment. The remediation plan is to be developed by the department in

consultation with the student. If the student's request to re-enroll is denied, the student may seek reconsideration through the Office of the Dean, College of Education & Professional Studies.

**VI. Executive Director's Report**

Dr. Bower gave the Executive Director's Report

1. Revised SPA reports were submitted for Science and Physical Education.
2. The Illinois Teacher Certification Board is discussing the possibility of limiting the number of attempts for all certification tests to 5 attempts per test.
3. The Illinois Teacher Certification Board is continuing discussions on middle school and secondary education endorsements.
