1. The State Teacher Certification Board is continuing discussion regarding how the State will handle program reviews in the future. Under current rules, those programs that have received conditional recognition, recognition with probation, or further development needed findings must submit their revised reports and receive national recognition by February 2011. Programs with Specialized Accreditation Organizations are required to submit a copy of their letter of accreditation.
2. The NCATE Steering Committee is currently working hard on the Unit report. A draft will be available early in the Fall semester.
3. Even though SPA Program Reports have been submitted, it is essential that education preparation programs continue to collect unit and program assessment data. We will need to have that documentation available for our 2010 NCATE visit.
