A discussion took place regarding revision of the bylaws. At the next meeting, a draft copy will be distributed indicating suggested changes.

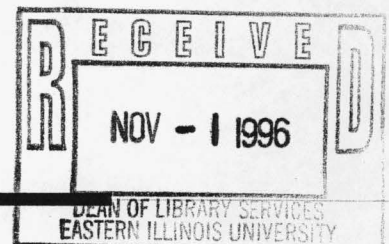
