**1. 10-33, Health Communication Minor (Revised Interdisciplinary Minor)**

Dr. Dietz and Dr. Gill presented the proposal and answered questions of the council.

Dr. Reid moved and Mr. Pickham seconded the motion to approve the proposal. The motion passed unanimously.

The proposal (**See Attachment B**) was approved, effective Fall 2010.

**2. 10-22R, BIO 3850, Environmental Biology (Revised Course)**

The agenda item was tabled at the February 4, 2010 CAA meeting. Subsequently, the proposal was revised and resubmitted to CAA for its review.

Today, Dr. Gaines and Dr. Carlsward presented the proposal and answered questions of the council.

Dr. Shelton moved and Dr. White seconded the motion to approve the proposal. The motion passed unanimously.

The proposal was approved, effective Fall 2010, *pending course fee approval*.

**3850 BIO. Environmental Biology. (2-3-3) On Demand.** An introduction to the principles of environmental sciences for biology majors. This course investigates the foundations of environmental science with particular attention to environmental problems from a biological perspective and the costs and benefits to their "solutions" from the local to global scale. This course pays particular attention to how to analyze, interpret and present scientific information in the life sciences. Prerequisites: BIO 1200G and BIO 1300G.

**3. 10-26, General Studies Degree Program (Revised Program)**

Dr. Woodward presented the proposal. There were no questions.

Ms. Green moved and Mr. Pickham seconded the motion to approve the proposal. The motion passed unanimously.

The proposal (**See Attachment C**) was approved, effective Fall 2010.

**4. 10-27, KSS 3550, Wrestling Coaching (New Course)**

Mr. McCausland presented the proposal and answered questions of the council. The council requested that the student learning objectives on the proposal be changed to measurable objectives (Part II, 1).

Dr. Sterling moved and Dr. White seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, effective Spring 2011.

**3550 KSS. Wrestling Coaching. (2-2-3) S.** Fundamentals of wrestling including offense techniques, defense techniques, coaching philosophy, training and conditioning guidelines, practice organization, rules and strategy. Prerequisite: Previous background or permission of the instructor.

**5. 10-28, KSS 4326, Psychosocial Aspects of Sports & Physical Activity (New Course)**

Dr. Walker presented the proposal and answered questions of the council. Dr. Hendrickson referenced communications from Dr. Eckert, Sociology, and Dr. Mace, Psychology, which were listed earlier on the agenda (See page two of the minutes – Communications: C.1 and C.2). The council requested the following revisions to the course proposal: list the student learning objectives in hierarchical order (Part II, 1) and include SOC 3000 as a similar course under Part IV, 3.

Ms. Ruholl moved and Dr. Bower seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, effective Fall 2011.

**4326 KSS. Psychosocial Aspects of Sport and Physical Activity. (3-0-3) On Demand. Psychosocial Aspects of Sport.** This course will analyze current trends in sport and physical activity organizations from a psychological and sociological perspective. Topics will be addressed from each perspective and emphasis will be placed on understanding issues from both an individual as well as an organizational perspective. Prerequisite: KSS 4325. The course is restricted to Sport Management majors in the Kinesiology and Sports Studies Department.

**6. 10-29, KSS 4880, Theory of Motor Behavior (Revised Course)**

Mr. Fertato presented the proposal and answered questions of the council. The council requested that the student learning objectives on the proposal be changed to measurable objectives (Part II, 1) and the asterisk behind objective 6 (Part II, 1) be changed to something else to avoid confusion with the asterisks shown in Part II, 2 and 3.

Ms. Ruholl moved and Dr. Bower seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, effective Summer 2010.

**4880 KSS. Theory of Motor Behavior. (3-0-3) Su. On Demand.** A study of the factors influencing human movement and skill learning. Emphasis will be placed upon theories and concepts relating to motor skill performance. The course is restricted to majors in the Kinesiology and Sports Studies Department

**7. 10-30, Kinesiology & Sports Management: Sport Management Concentration (Revised Concentration)**

Dr. Owen presented the proposal. There were no questions.

Dr. Sterling moved and Dr. Hendrickson seconded the motion to approve the proposal. The motion passed unanimously.

The proposal (**See Attachment D**) was approved, effective Fall 2011.

**8. 10-31, Art History Option (Revised Option)**

Mr. Hild presented the proposal and answered questions of the council. Dr. Hendrickson read out loud the communication from Dr. Chris Mitchell (See Attachment A). Mr. Hild addressed the communication during his presentation.

Dr. Hendrickson moved and Ms. Green seconded the motion to approve the proposal. The motion passed with the following vote.

Just to remind that I will not be at this week's CAA meeting due to conference activity.

There is one agenda item for which I would like to offer a comment on -- if you'd pass it on to the group, I'd be appreciative.

Agenda Item 10-31, the Art History Option, an item to be acted upon:

If I read the proposal correctly, the proposed curriculum change in great part involves sacrificing 9 credits of HIS courses in favor of adding 3 hours of Art History electives. As a theatre historian, and as an advisor who encourages theatre history-oriented students to take courses in HIS as part of integrative learning, I must say I have grave reservations about no longer requiring these students to take these HIS courses formerly part of the curriculum (HIS 2560, 3555, and one of 1500G, 1510G, and 1520G) and really would like justification as to why it is deemed no longer necessary for an art history student.

The School of Continuing Education Bachelor of Arts in General Studies Degree Program is an individualized, nontraditional program designed for working adults. The program combines sound academic principles with advances in technology to facilitate degree completion. After admission to the program knowledge and skills acquired by non-academic means can be evaluated for academic credit.

1. A student must be admitted to this program by the Director of the Bachelor of Arts in General Studies Degree Program.
2. After the student is admitted to the program, only grades of "C" and above will be counted toward meeting graduation requirements. Grades of "D" and "F" earned after admission to the program will be included in the cumulative EIU grade point average, consistent with current EIU grade policy.
3. **After admission to the program, students may use no more than five (5) one-credit-hour courses towards their degree.** It is recommended that no more than ten one-credit-hour workshops may be used toward the degree.
