#### VI. NCATE

Dr. Bower and Dr. Fewell presented information on the revised conceptual framework document, with a focus on the dispositions section of the document. A copy of the revised conceptual framework document was distributed. Council members are asked to review the materials and share with their constituents. They should provide feedback to Dr. Bower by January 15, 2008. A draft of this document is also available for viewing on the COTE website. The Council will be asked to vote on the final approval of this document at the January 22, 2008, meeting.

Dr. Bower gave an update on the meetings held during the Fall semester: NCATE planning meeting for all faculty (11/6/07) and program coordinators meeting (11/14/07). Based upon feedback from these two meetings, program coordinators will meet regularly during the Spring semester and the unit faculty will have three meetings during the Spring semester. The first meeting will be held in early February on NCATE standards 1 and 2, Data. The second meeting will be held in March on NCATE standard 3, Field Experiences. The third meeting will be held in April on NCATE standard 4, Diversity.
