**HIS 4815. History of Ireland and the Irish, 1600 to Present. (3-0-3) S. Modern Irish History.** This course focuses on twentieth-century issues and events in Ireland but roots these in the Anglo-Scot settlements of the seventeenth century, the romantic nationalism of the late-eighteenth century, and the rural conflict and famine of the nineteenth. It also examines the Irish diaspora outside the isle, as well as the IRA and the UDA in modern Northern Ireland. Prerequisites: None. Course may not be repeated.

3. 08-32, Kinesiology & Sports Studies Degree Title Change & Prefix Change (New Proposal)

**Attachment A****Degree Title Change & Prefix Change****REQUEST:**

The Kinesiology and Sports Studies Department proposes to the Council on Academic Affairs that the name of the B.S. and M.S. degree titles be changed from Physical Education to Kinesiology and Sports Studies and the prefix to all classes be changed from PED to KSS.

**RATIONALE:**

A departmental ad hoc committee voted 8 to 3 to change the name of the Department of Physical Education to the Department of Kinesiology and Sports Studies based on rationale which also apply to a change in degree title.

1. The name Kinesiology and Sports Studies provides a better indicator of the different Physical Education fields of study which include: athletic training, exercise science, physical education, and sports management.
2. The majority of similar university programs nationwide use the term Kinesiology within their degree title. A similar degree title change at EIU would be more consistent with other universities throughout the state and nation.

Therefore, a change in degree title to Kinesiology and Sports Studies and class prefix to KSS would be consistent with the change in departmental name, more accurately reflect the different degree options provided within the department, and be consistent with similar degrees offered nationwide.
