Dr. Sterling moved and Dr. Hoerschelmann seconded the motion to add these items to the agenda.

Dr. Mace and Dr. Stowell presented the proposal and answered questions of the council.

Ms. Green moved and Dr. Klarup seconded the motion to approve the proposal. The motion passed unanimously.

The proposal (**See Attachment A**) was approved, *effective Fall 2011*.

2. 10-85, ART 3912, Interactive/Motion Graphics I (New Course); 10-86, ART 3922, Interactive/Motion Graphics II (New Course); 10-87, ART 4912, Interactive/Motion Graphics III (New Course); and 10-88, ART 4922, Interactive/Motion Graphics IV (New Course).

Mr. Hild and Mr. Richardson presented the proposals (agenda items 10-85, 10-86, 10-87, and 10-88) as a package and answered questions of the council. Next the council reviewed, asked additional questions, and voted on each proposal individually (See below). Also, Mr. Hild noted revisions to the ART 4912 (See 2.c. below) and ART 4922 (See 2.d below) proposals.

a.) 10-85, ART 3912, Interactive/Motion Graphics I (New Course)

Dr. Shelton moved and Ms. Green seconded the motion to approve the proposal. The motion passed unanimously.

The proposal was approved, *effective Fall 2011*.

ART 3912. Interactive/Motion Graphics I. (0-6-3) F. An introduction to effective visual problem-solving in interactive/motion graphics design. Fundamentals of interactive media will be emphasized. Prerequisites: ART2910 and ART2920 (May not be taken concurrently.) Course restricted to students admitted to the BFA in Art Graphic Design Option.

b.) 10-86, ART 3922, Interactive/Motion Graphics II (New Course).

Ms. Green moved and Dr. Sterling seconded the motion to approve the proposal. The motion passed unanimously.

The proposal was approved, *effective Spring 2012*.

ART 3922. Interactive/Motion Graphics II. (0-6-3) S. Effective visual problem-solving in interactive/motion graphics design. Fundamentals of animation/motion design will be emphasized. Prerequisite: ART3912 (May not be taken concurrently.) Course restricted to students admitted to the BFA in Art Graphic Design Option.

c.) 10-87, ART 4912, Interactive/Motion Graphics III (New Course).

Mr. Hild asked that the course's initial term of offering be changed from Fall 2012 to Fall 2011. Also, he explained that the Council of Graduate Studies had requested revisions to the proposal at its meeting on November 16, 2010. He provided an explanation of those changes and indicated he would forward, which he subsequently did, the revised proposal to Ms. Fopay, CAA Recording Secretary.

ART 4912. Interactive/Motion Graphics III. (0-6-3) F. Interactive/Motion Graphic III.

Advanced communication problem-solving, emphasizing the integration of animation/motion graphics and interactive design. Prerequisite: ART 3922. Course restricted to students admitted to the BFA in Art Graphic Design Option.

d.) 10-88, ART 4922, Interactive/Motion Graphics IV (New Course).

Mr. Hild explained that the Council of Graduate Studies had requested revisions to the proposal at its meeting on November 16, 2010. He provided an explanation of those changes and indicated he would forward, which he subsequently did, the revised proposal to Ms. Fopay, CAA Recording Secretary.

Mr. Hild presented the proposal and answered questions of the council. The council requested changes to number 3 on the proposal.

Dr. Sterling moved and Ms. Green seconded the motion to approve the proposal. The motion passed unanimously.

The proposal (**See Attachment B**), with revisions, was approved, *effective Fall 2011*.

Dr. White, CAA Chair, presented the proposal to the council. There were no questions.

Ms. Green moved and Dr. Lucas seconded the motion to approve the proposal. The motion passed unanimously.

Art: Graphic Design Option (B.F.A.)

An option in the Art (B.F.A.) offerings.

Graphic Design Selective Admissions Entrance Requirements

Students wishing to major in Graphic Design are required to apply for admission into the Junior (3rd) year of the program. Freshman and sophomore year, or "Pre-Graphic Design," remains open to all who wish to enroll. Entrance into the Junior (3rd) year of the program, or the "Graphic Design Program," is determined by the Graphic Design Selective Admissions Committee. Admission to the program is limited to those students who have satisfied the specific course requirements (ART 1000, 1001, 1110, 1111, ~~2050~~, 2500, ~~2560~~, 2601, 2602, 2910, 2920, **3 credit hours from 2050 or 2560**, and ENG 1001G and 1002G), have a minimum cumulative GPA of 2.25 for all coursework, and a minimum GPA of 2.75 for all Art coursework, and submit an art and design **digital** portfolio. The art and design **digital** portfolio will be reviewed and ranked by the Graphic Design Selective Admissions Committee. **The art and design digital portfolio must receive a score by the Selective Admissions Committee of 2.75 or higher on a 4.0 scale.** Admission into the program is based on a comparative scoring system of performance in the above requirements (cumulative GPA, Art GPA, completion of required coursework, art and design **digital** portfolio).

Exceptions to these requirements can be made only in response to written requests and the subsequent review and recommendation of the Graphic Design Selective Admissions Committee.

Attachment C**Amendments to CAA Bylaws****Article VII. Jurisdiction and Procedures**

4. Procedures of the Council on Academic Affairs

a. Meetings

(3). All meetings shall adhere to the provisions of the Illinois Open Meetings Act.

~~(4). Electronic meetings may be held when the Council determines that all items on the agenda are non-controversial.~~

b. Agenda

(1). The agenda of each meeting shall be available ~~to all members of the Council~~ at least 48 hours in advance of the meeting. It is recommended that this be published as a supplement to the minutes of the previous meeting or with the notice of the ~~next~~ meeting.

d. Handling of Proposals

(6). In order to be placed on the agenda, a proposal must be moved and seconded by a member of the Council. The agenda item is then published in the minutes of the Council and is voted on in a subsequent meeting. Alternatively, in the event a meeting is cancelled, the Chairperson of the Council may place a proposal on the agenda for a future meeting. The agenda item is then to be published with the notice of the meeting cancellation and can be voted on at a subsequent meeting.

(12). Final action may be taken on a proposal ruled non-controversial by the Executive Officer and the Chairperson after the item has appeared on the agenda without the motion having been published in the minutes or published with the announcement of a meeting cancellation. In some exceptional cases, final action on a proposal which has been declared non-controversial by the Executive Officer and the Chairperson may be taken before it has appeared on the agenda of the Council, if the Council by a two-thirds vote of those present, suspends this rule to take immediate action.

~~A motion and second may be accepted on a proposal that is ruled controversial by either the Executive Officer or the Chairperson but final action may not be taken until the motion has appeared in the minutes.~~ Final action may not be taken on a proposal that is ruled controversial by either the Executive Officer or the Chairperson unless the proposal (1) has been published with the meeting agenda and (2) has previously been published in the minutes as moved and seconded or published with the notice of a meeting cancellation. This rule may not be suspended.

Rationale: A recent modification to the Illinois Open Meetings Act requires that a “quorum of members of a public body must be physically present at the location of an open meeting.” Therefore, electronic meetings are no longer viable. The Act further requires that an agenda must be published at least 48 hours before any meeting. In addition, it has been the intent of CAA that proposals coming up for a vote should be publicized at least a week before the vote. These proposed amendments maintain that intent while complying with the law.
