CEPS 05-02, Change the Introduction to Education course required for Physical Education majors to PED 2000.

Dr. Phoebe Church presented the proposal to change the Introduction to Education course required for Physical Education majors from PED 1500 to PED 2000 for the purpose of University Approval to Take Teacher Education Courses. Dr. Hooser pointed out that this change will also affect the Unit Assessment System, so the proposal was amended to include this change. Following discussion, this proposal was unanimously approved as amended. Effective date is Spring 2006.

CEPS 05-03, New Course - PED 4980 Advanced Coaching/"Name of Sport"

Dr. Church presented the proposal for this new course. Following discussion, this proposal was unanimously approved as amended. Effective date is Summer 2006.

CEPS 05-04, New Course - PED 3180 General Medical Conditions in the Athlete

Dr. Church and LeeAnn Price presented the proposal for this new course. Following discussion, this proposal was unanimously approved as amended. Effective date is Spring 2007.

CEPS 05-05, Program Revision - Physical Education with Athletic Training Option

Dr. Church presented the proposal to revise this program. Following discussion, this proposal was unanimously approved. Effective date is Fall 2006.

CEPS 05-06, New Course - REC 3400G World Leisure: A Cultural Perspective

John Weber presented the proposal for this new course. Following discussion, this proposal was unanimously approved as amended. Effective date is Fall 2006.
