

- I. Approval of the January 31, 2008 CAA Meeting Minutes. The minutes of January 31, 2008 were approved as written.

Ms. Fopay noted the following corrections for past meeting minutes.

1. Correction to page 4 of the 10/25/07 CAA Minutes -

The executive action request for MAR 4490 should have read "Revise the course description for MAR 4490 and remove the writing-intensive designation." The statement "remove the writing-intensive designation" was left out of the minutes by mistake.

2. Correction for the 1/10/08 and 1/24/08CAA Minutes -

#### Effective Fall 2008

1. Revise the course description for MAR 4490 and remove the writing-intensive designation.

4490 MAR International Marketing. (3-0-3) F, S. An introduction to foreign trade with emphasis on international marketing institutions, cooperation, and technical features of overseas operations. Study of marketing from the international perspective. Emphasis is placed on necessary modifications of marketing strategy and practice related to global pricing and distribution, product planning, and promotions due to cultural, economic, environmental and legal differences. Prerequisite: BUS 3470 and admission to the School of Business or permission of the Associate Chair. <del>WI</del>

# Correction of the 1/10/08 and 1/24/08 CAA Minutes BAS

## Effective Fall 2008

1. Remove the writing-intensive designation for MIS 3530.

**3530 MIS Business Web Site Design. (3-0-3) F.** Fundamentals of designing effective web sites including graphics and animation using web application software. Some HTML and JavaScript will be introduced. Students will develop web sites with a focus on information architecture and usability standards for business web sites. Prerequisites: BUS 1950 and junior standing and admission to the School of Business or to a minor offered by the School of Business or permission of the Chair, School of Business. WH

#### Effective Fall 2008

1. Revised the course description and prerequisites for ENG 3401.

**3401 ENG Methods of Teaching Composition in the Secondary School. (3-0-3) F, S.** Approaches to the teaching of composition in junior and senior high school. Electronic interaction with secondary student writers. Includes 5 on-site hours and 5 hours of laboratory on-site pre-clinical experience. Prerequisites: ENG 2901 and SED 2000. , 3001; SED 3330 and EDP 3331; for ISEP students, SED 3000 and 3100; for Middle Level Education majors, MLE 3110. (Group 1) WI

2. Change the course description and prerequisites for ENG 3402

**3402 ENG Methods of Teaching Literature in the Secondary School. (3-0-3) F, S.** Approaches to the teaching of literature in junior and senior high school. Includes 5-onsite hours and 5 laboratory hours of on-site pre-clinical experience. Prerequisite: ENG 1002G, EDP 3331, and SED 3330; for ISEP students, SED 3000 and 3100; for Middle Level Education majors, MLE 3110. Prerequisites: ENG 2901 and SED 2000. Prerequisites or co-requisites: EDP 3331 and SED 3330; for ISEP students, SED 3000 and 3100; for Middle Level Education majors, MLE 3110. (Group 1) WI

3. Amend the course description and prerequisites for ENG 4801

**4801 ENG** Integrating the English Language Arts. (3-0-3) F, S. Strategies for integrating the English language arts, including literature, composition, speech, drama, and works in other media such as film. Attention to pedagogical theory and its practical applications. Includes 5 hours of on-site pre-clinical experience. Prerequisites: ENG 1002G, 3001; ENG 2901, SED 3330 and EDP 3325 3331; for ISEP students, SED 3000 and 3100; for Middle Level Education majors, MLE 3110. (Group 1) WI

#### COS Effective Fall 2008

1. Change the course prerequisites of MAT 1160G.

**1160G MAT Mathematics: A Human Endeavor. (3-0-3)** Development of mathematical reasoning and problem solving, through concentrated study of three or four topics. Areas may include logic, sets, probability, statistics, graph theory, number theory, and/or geometry. Prerequisite: ENG 1001G; and satisfactory completion (C or better) of high school Geometry and Intermediate Algebra, or MAT 1271. This course should not be considered as preparatory for other courses in mathematics. ENG 1001G. This course may not be taken by students with a high school mathematics deficiency that has not been removed. This course should not be considered as preparatory for other courses in mathematics.

2. Revise the course prerequisites of MAT 1170G.

1170G MAT Problem Solving. (3-0-3) F, S. A writing-intensive course in which students are presented with challenging problems in mathematics and are required to develop their own problem solving strategies and tactics. Prerequisite: ENG 1001G; and satisfactory completion (C or better) of high school Geometry and Algebra II, or MAT 1271. This course should not be considered as preparatory for other courses in mathematics. ENG 1001G. This course may not be taken by students with a high school mathematics deficiency that has not been removed. This course should not be considered as preparatory for other course should not be considered as preparatory.

3. Modify the course title of MAT 1420.

**1420 MAT** Introductory Mathematics and Numeration Mathematics for Elementary Teachers I. (3-0-3) F, S. The study of the concepts and theory of numeration, probability, and statistics as well as the development of the numeration system via a problem-solving approach using both calculators and microcomputers throughout. Open only to early childhood, elementary, middle level, or special education majors. Prerequisite: Placement by ACT Mathematics score.

4. Amend the course title and prerequisites of MAT 2420G.

2420G MAT Introductory Geometry Mathematics for Elementary Teachers II. (3-0-3) F, S. Geometric relationships using a problem solving approach and higher order thinking skills. Topics investigated from practical and theoretical viewpoints, emphasizing understanding via concrete modeling, as suitable for pre-service K-8 teachers. Open only to early childhood, elementary, middle level, or special education majors. Prerequisite: Satisfactory completion (C or better) of high school Geometry and Intermediate Algebra, and MAT 1420, with a C or better. MAT 1420, with grade of C or better. This course may not be taken by students with a high school mathematics deficiency that has not been removed. M1 903

5. Change the course number of SOC 3610 to 3630 and add a course prerequisite.

**3610 3630 SOC Statistical Analysis of Social Data (3-2-4) F, S.** Survey of statistical techniques used to summarize and describe the quantitative characteristics of social research. The course includes both descriptive and inferential statistics, using statistical software to analyze data. **Prerequisite: SOC 3620.**

## Information on EWP Revisions for Continuing Students

## **Continuing Native Students**

**Continuing native students** who have submitted **three documents** by the end of SU08 have fulfilled their EWP requirements.

**Continuing native students** with **two documents** submitted by the end of SU08 will need to submit one more paper by the time they earn 105 hours; they will not be subject to the remediation portion of the new EWP.

**Continuing native students** with **one paper** submitted by the end of SU08 will need to submit two more papers: one by the time they have earned 60 hours (a hold will be placed at 75 hours) and the last by the time they have earned 105 hours. They will not be subject to the remediation portion of the new EWP.

**Continuing native students** who have **not yet submitted** to the EWP must submit three documents to the EWP: two by the time they have earned 60 hours (a hold will be placed at 75 hours) and the last one by the time they have completed 105 hours. They will not be subject to the remediation portion of the new EWP.

## **Continuing Transfer Students**

Continuing transfer students who attended Eastern Illinois University prior to FA08 will submit the number of papers required at the time of matriculation: 3 submissions if 1-59 hours were transferred; and 2 submissions if 60 or more hours were transferred. They will not be subject to the remediation portion of the new EWP.

## Portfolio Completion

Continuing students who started classes before FA08 will complete some version of the new EWP.

Students who graduate in Spring 2008 or Summer 2008 will complete the current EWP instituted in 2000-2001.
