**Late/Retroactive Withdrawals**

A student may request a late/retroactive withdrawal through the course instructor when a documented illness or extraordinary circumstance prevents withdrawal from a course by the established deadlines. Failing a class is not an appropriate reason to seek a late/retroactive withdrawal. Students who are failing a course should follow the "Repeating Courses" policy stated in the catalog. The deadline for a filing for a late withdrawal for fall semester is March 15th for the immediately preceding fall semester and October 15th for the immediately preceding spring or summer. ~~Students will be assessed a non-refundable \$25 Late Withdrawal Fee per late withdrawn credit with a maximum of \$100 per occurrence upon submission of the request.~~ **Students will be assessed a non-refundable Late Withdrawal Fee of \$25 per late withdrawal credit requested with a maximum of \$100 per occurrence.**

The Office of the Registrar and Enrollment Management will forward all appeals of the Registrar's determination of Late/Retroactive Withdrawal to the Appeal Committee, whose decision is final and not subject to further appeal.

4. October 23, 2009 memorandum from Dr. Mary Herrington-Perry, Academic Affairs, regarding revisions to the record retention policy for academic materials.  
*At its October 5, 2006 meeting, CAA approved a new policy governing record retention of academic materials used to determine student grades. Afterwards, the item was sent to the Council on Graduate Studies (CGS) for approval, but was removed from its agenda on April 17, 2007 until the State of Illinois could provide additional information. The item was re-added to the CGS agenda and approved by CGS, with revisions (**See below**), pending the President's Council approval, at its October 20, 2009 CGS meeting.*

*Today, the CAA members did not express concerns about the revisions, so Dr. Herrington-Perry will forward the revisions (**See below**) to the President's Council for approval.*

**Record Retention for Academic Materials.** Instructors shall keep accurate records of all marks which are used in determining a student's grade and shall retain such records for at least one academic year from the date on which the grade was submitted. Instructional staff members ~~who are going on leave~~ **will be unavailable for one semester or more** or who are leaving the employ of the University shall ~~deposit~~ **make** copies of such grading records **accessible to the department chairperson** in departmental (or college) offices.

All papers, exams, reports, etc., submitted by students in fulfillment of course requirements and not returned to students also shall be subject to these provisions. Unless informed otherwise in writing, students shall normally have the right to examine such exams and papers, etc., under conditions and stipulations determined by the course instructor.

**2324 INT Electronic Control Systems. (2-2-3) F, S.** An introduction to basic electrical industrial control concepts. Topics included basic electrical concepts, basic electrical automation and control concepts, introduction to loads and actuators, control sequencing and data acquisition fundamentals. Prerequisite: MAT 1270 **or Math ACT score of 20 or higher.**

2. Update the prerequisites for INT 2523.

**2523 INT Routing and Switching Fundamentals. (2-2-3) F.** An in-depth hardware course in computer hardware systems, Open Systems Interconnect (OSI) model layers, configuration details of Internet Protocol routing, switching topics, and router operation as applied to industrial settings. Prerequisite: ~~BUS 1950~~ **INT 1323.**

3. Update the prerequisites for INT 4673.

**4673 INT Work Measurement and Method Design. (3-0-3) S.** Principles of motion and time study and methods engineering for the purpose of increasing productivity and reducing human effort. Special emphasis will be given to design and measurement of work in industrial environments. Prerequisite: ~~INT 1263 and~~ MAT 2110G or 1441G.

**4803 INT Plant Layout and Material Handling. (3-0-3) F.** Study of the arrangement of physical facilities and material handling to optimize the interrelationships among operating personnel, material flow, and the methods required in achieving enterprise objectives efficiently, economically, and safely. Prerequisite: **INT 1323, INT 2043, and ~~INT 1263~~ MAT 2120G or 1441G.**

**4833 INT Automatic Identification and Data Capture. (2-2-3) F, S.** A study of the methods and systems used to automatically identify objects. ### **I. Community Health Promotion/Education Concentration**

A minimum of 15 semester hours of course work including study in the areas of introductory psychology, mass communications, educational psychology, and school health.

Recommended Minors: Adult Education, Creative Writing, Family and Consumer Sciences, Journalism, Public Relations, Psychology, Communication Studies, Professional Writing

### **II. Community Health Counseling Concentration**

A minimum of 15 semester hours of course work including study in the areas of group dynamics, behavior management, human nutrition and food study, and techniques of counseling and guidance.

Recommended Minors: Psychology, Family and Consumer Sciences (family services)

### **III. Community Health Administration Concentration**

A minimum of 15 semester hours of course work including study in the areas of business administration, American national government, state and local government, and economics. It is highly recommended that students in this concentration pursue a minor in Business Administration.

Recommended Minors: Business Administration, Political Science, Economics.
