Insert: P 91, 2001—2002 catalog, column two, after first partial paragraph, top of the right column.

Individuals who hold a valid teaching license, have student taught previously in completion of an approved teacher education program, and document one year or more successful teaching experience as the teacher responsible for delivering the Special Education components of the individualized educational program, may substitute completion of 6 s.h. of Special Education coursework specific to instructional strategies for the student teaching experience. This coursework must result in successful completion of supervised, evaluated practica.

2. 02-05, Revision to the Alternate Secondary Education Program.

Dr. Kathlene Shank presented the proposal, distributed additional information and answered questions of the Council. Dr. Mahmood Butt also distributed information and answered questions of the Council. The proposal was defeated by the following vote:
