The April 9, 2009 meeting of the Council on Academic Affairs was held at 2:04 p.m. in Room 4440, Booth Library.

Ms. Dilworth moved and Dr. Hendrickson seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, effective Fall 2010.

3253 PLS. International Criminal Law. (3-0-3) F. This course examines the evolution in international criminal law during the 20th century and addresses efforts to codify legal norms involving genocide, crimes against humanity and war crimes as well as the institutions involved in the implementation of international criminal law. Prerequisite: Students must have completed PLS 2253 before taking this course.

2. 09-22, Political Science (Revised Major)

Dr. Wandling and Dr. Barria presented the proposal and answered questions of the council.

Dr. Sterling moved and Ms. Alexander seconded the motion to approve the proposal. The motion passed unanimously.

The proposal (**See Attachment A**) was approved, effective Fall 2010.

3. 09-23, Political Science: International Studies Option (Revised Option)

4. 09-31, ART 2400, Introduction to Art Education (Revised Course)

Dr. Belleville and Mr. Hild presented the proposal and answered questions of the council.

Ms. Alexander moved and Ms. Dilworth seconded the motion to approve the proposal. The motion passed unanimously.

The proposal was approved, effective Fall 2010.

2400 ART. Introduction to Art Education. (3-0-3) F. Introduction to the philosophical foundations of the field of Art Education and the various contexts within which art teaching functions. Twenty clock hours of pre-student teaching experience included. Prerequisite: Enrollment in the Art Education Option. WI

5. 09-32, ART 2749, Research Methods and Professional Practices (New Course)

Mr. Hild and Dr. Belleville presented the proposal and answered questions of the council. The council requested revisions to the course description and technology-delivered section of the proposal.

Ms. Dilworth moved and Dr. Hyder seconded the motion to approve the proposal. The motion passed with the following vote:

The proposal, with revisions, was approved, effective Fall 2009. The course will replace ART 3011.

2749 ART. Research Methods and Professional Practices. (1-0-1) F, S. Research Meth/Prof Practices. The Research Methods and Professional Practices course provides art students with an introduction to the basic skills necessary to document and digitally format artwork; as well as research, evaluate, and write about art in preparation for a career in Studio Art, Art Education and Art History. Course restricted to Art Majors.

6. 09-33, ART 3405, Art Education for Elementary Schools Studio (Revised Course)

Mr. Hild and Dr. Belleville presented the proposal and answered questions of the council. The council requested revisions to the student learning objectives, course unit of time, course justification, and the faculty member entry on the proposal.

Ms. Dilworth moved and Ms. Alexander seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, effective Spring 2010.

3405 ART. Art Education for Elementary Schools Studio. (0-6-3) S. Elementary Art Methods Studio. This is a studio intensive course designed to present art education students with experience using art media and techniques appropriate for the elementary and middle school. In addition to studio techniques students will develop objectives and lesson plans. The studios are designed to reinforce and enhance reading assignments, activities, discussion in ART 3400. Must be taken concurrently with ART 3400. Prerequisites: ART 2400, admission to the Art Education Program, and admission to the College of Education Teacher Certification Program. WA

7. 09-34, ART 3415, Art Education for Secondary Schools Studio (Revised Course)

Mr. Hild and Dr. Belleville presented the proposal and answered questions of the council. The council requested revisions to the student learning objectives and course unit of time on the proposal.

Ms. Green moved and Dr. Campbell seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, effective Fall 2010.

3415 ART. Art Education for Secondary Schools Studio (0-6-3) F. Secondary Art Methods Studio. This is a studio intensive course designed to present art education students with experiences using art media and techniques appropriate for the secondary level. In addition to studio techniques, students will write lesson plans correlating to the studio activities. The studio activities are designed to reinforce and enhance reading assignments, activities and discussions in ART 3410. Must be taken concurrently with Art 3410. Prerequisites: ART 3400, ART 3405, admission to the Art Education Program, and admission to the College of Education Teacher Certification Program. WI

8. 09-35, ART 4749, Senior Portfolio (New Course)

Mr. Hild and Dr. Belleville presented the proposal and answered questions of the council. The council requested a revision to the grading method on the course proposal.

Ms. Green moved and Ms. Alexander seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, effective Fall 2010.

4749 ART. Senior Portfolio. (Arr-Arr-0) F, S. (Credit/No Credit) Students in the BFA in Studio Art Option or Graphic Design Option demonstrate competency in the major through submission of a senior portfolio. Portfolio requirements and submission time line are available from the department office. Co-requisites: Enrollment in a 4000-level Studio Art or Graphic Design course. Prerequisite: Senior standing in either the BFA in Art with Option in Studio Art or the BFA in Art with Option in Graphic Design.

9. 09-36, Art Major: B.F.A. in Art with option in Graphic Design (New Degree Program)

Mr. Hild presented the proposal and answered questions of the council.

Ms. Alexander moved and Dr. White seconded the motion to approve the proposal. The motion passed unanimously.

The proposal (**See Attachment C**) was approved, effective Fall 2010, *pending IBHE approval*.

Note: This major will replace the B.A. in Art Major: Graphic Design Option. The last term in which students may be admitted to the B.A. in Art Major: Graphic Design Option will be Summer 2010.

10. 09-37, Art Major: B.F.A. in Art with option in Studio Art (New Degree Program)

Mr. Hild presented the proposal and answered questions of the council. The council requested clarification of the degree name on the proposal.

Dr. Sterling moved and Ms. Alexander seconded the motion to approve the proposal. The motion passed unanimously.

The proposal (**See Attachment D**), with revisions, was approved, effective Fall 2010, *pending IBHE approval*.

11. 09-38, Art Major: B.A. in Art with Studio Art Option (Revised Program)

Mr. Hild presented the proposal and answered questions of the council. He noted a correction to the proposal – ART 3011 should be removed from the program.

Ms. Green moved and Dr. Hyder seconded the motion to approve the proposal. The motion passed unanimously.

Dr. Sterling reported the Professor Laureate Committee received several nominations for the professor laureate and indicated that all of the candidates were outstanding. He said the Professor Laureate Committee recommends Dr. Reid Benedict as the 2009 Professor Laureate.

Ms. Dilworth moved and Dr. Reid seconded the motion to accept that recommendation. The motion passed by acclamation.

In addition, Dr. Sterling explained that the Professor Laureate Committee found the current professor laureate criteria and the guidelines for the nomination process somewhat ambiguous; and thus suggested that CAA review and possibly re-write them. Dr. Bower requested that the Professor Laureate Committee undertake that task and submit a proposal for CAA to review at a future meeting.

Art Major: Bachelor of Fine Arts (BFA) with option in Graphic Design

B.F.A. in Art Major: Graphic Design Option

Graphic Design Selective Admissions Entrance Requirements

Students wishing to major in Graphic Design are required to apply for admission into the Junior (3rd) year of the program. Freshman and sophomore year, or "Pre-Graphic Design," remains open to all who wish to enroll. Entrance into the Junior (3rd) year of the program, or the "Graphic Design Program," is determined by the Graphic Design Selective Admissions Committee. Admission to the program is limited to those students who have satisfied the specific course requirements (ART 1000, 1001, 1110, 1111, 2050, 2500, 2560, 2601, 2602, 2910, 2920, and ENG 1001G and 1002G), have a minimum cumulative GPA of 2.25 for all coursework, and a minimum GPA of 2.75 for all Art coursework, and submit an art and design portfolio. The art and design portfolio will be reviewed and ranked by the Graphic Design Selective Admissions Committee. Admission into the program is based on a comparative scoring system of performance in the above requirements (cumulative GPA, Art GPA, completion of required coursework, art and design portfolio).

Exceptions to these requirements can be made only in response to written requests and the subsequent review and recommendation of the Graphic Design Selective Admissions Committee.

The portfolio of artwork will be reviewed and ranked by the Foundations and Studio Area faculty. Admission in the program is based on a comparative scoring system of performance in the above requirements (cumulative GPA, Studio Art GPA, completion of required coursework, portfolio of artwork, statement of intent).

Exceptions to these requirements can be made only in response to written requests and the subsequent review and recommendation of the Foundations and Studio Area faculty.
