#### 2. 09-02, Request to remove the writing-intensive designation from PLS 2033.

The proposal was approved. The writing-intensive designation will be removed from PLS 2033, effective Fall 2009.

2033 PLS Research Methods in Political Science. (3-0-3) F, S. The goal of this course is to introduce students to research methods in Political Science. Students will learn both qualitative and quantitative methods for carrying out political science research. Students also will learn how to use scholarly literature to support their analysis and how to write research papers in Political Science. Prerequisites: Students who are not Political Science majors or Social Science Teaching majors with a Political Science Designation must have permission of the instructor. WI

#### VIII. Discussion of the Report from the Ad Hoc Committee on Cultural Diversity.

At last week's CAA meeting, Dr. Mikki Meadows, Chair of the Ad Hoc Committee on Cultural Diversity, presented the report and answered council members' questions. Today, Dr. Bower summarized the report and the council discussed it and cultural diversity. The council requested that the report be sent back to the ad hoc committee for the following revisions:

- 1. Identify who the report is from
- 2. List the names of each ad hoc committee members
- 3. Add the report date
- 4. Provide an explanation of how the data was collected by the ad hoc committee
- 5. Note how often the ad hoc committee members met
- 6. Explain how conclusions were drawn by the ad hoc committee

In addition to revising the report, the council also requested the following from the Ad Hoc Committee on Cultural Diversity:

- 1. Create guidelines by which cultural diversity courses are assigned the cultural diversity designation
- 2. Provide a recommendation on such guidelines to the council

# IX. Discussion of the Senior Seminar results collected by the Senior Seminar Review Subcommittee.

At the March 30, 2006 CAA meeting the council approved a charge to CAA to establish a Senior Seminar Review Subcommittee to assess whether the senior seminars are meeting the goals set forth in senior seminar mission. Data was collected by the Senior Seminar Review Subcommittee and at last week's CAA meeting, Dr. Bower requested that the council members review it. Today, she summarized the data and the council discussed whether additional data were needed. In addition, the council discussed senior seminars. Some of the topics discussed were whether the senior seminars were doing what they are intended to do, values and views of students regarding senior seminars, assessment, differences in the way senior seminars are taught, and whether senior seminars should remain interdisciplinary or become a capstone experience within majors.

The council concluded that more data was needed and created a subcommittee to study senior seminars, review existing data, collect additional data pertaining to senior seminars, look at capstone experiences at other universities, review other matters as deemed appropriate by CAA, and to submit a recommendation to CAA by April 16, 2009.

#### Effective Fall 2009

1. Revise the course description for ACC 4275.

4275 ACC Internship in Accounting. (Arr.-Arr.-1-42 15) (Credit/No Credit) Monitored work or service experience requiring development and application of accounting knowledge and skills. Prerequisite: Admission to the Accounting Program, ACC 3200, ACC 3300, a minimum cumulative EIU GPA of 2.50 or higher, and approval of Internship Learning Agreement by School of Business Associate Chair. Up to 12 hours of internship credit may be counted for graduation. Course may be repeated for credit.

2. Change the prerequisites for MAR 4700.

**4700 MAR Marketing Strategies. (3-0-3) F, S.** A study of the analysis, planning, implementation and control of marketing activities which are designed to achieve consumer satisfaction and the objectives of the organization. Prerequisite: BUS 3470, MAR 3490, MAR 3550, MAR 3720, MAR 3860, MAR 4470, senior standing, and admission to the School of Business or permission of the Associate Chair.

#### CAH/COS

#### Effective Fall 2009

1. Add GPA requirements to the SOS 3400 course prerequisites.

**3400 SOS Methods and Materials in the Social Studies in the Secondary School. (3-1-3) F, S.** Aims and goals of social studies teaching; nature and scope of social studies materials; methods used in teaching the social studies, including those employing instructional technology. Thirty clock hours in clinical experiences are required. This course is designed to meet the needs of students who will receive Social Science Teaching Certification. Prerequisite: SED 3330 and EDP 3331; for ISEP students, SED 3000 and SED 3100; for Middle Level Education majors, MLE 3110. For students under catalogs prior to fall 2008, a major grade point average of 2.75 and a cumulative grade point average of 2.75; for students under catalogs from fall 2008 and later, a 3.00 major grade point average and a 2.75 cumulative grade point average. These requirements are effective fall 2009.
