

Council on Academic Affairs Minutes January 29, 2009

The January 29, 2009 meeting of the Council on Academic Affairs was held at 2:05 p.m. in Room 4440, Booth Library.

I. Approval of the January 22, 2009 CAA Meeting Minutes.

The minutes of January 22, 2009 were approved as written.

Dr. Bower noted that Dr. Melinda Mueller, the current professor laureate, will serve on the Professor Laureate Subcommittee with Dr. Grant Sterling (Chair), Dr. Julie Campbell, and Ms. Jackie Alexander.

II. Communications:

- a. College Curriculum Committee Minutes:
 - 1. Minutes of the January 16, 2009 College of Sciences Curriculum Committee meeting.

b. Executive Action Requests:

- 1. January 12, 2009 memorandum from Dean Hoadley, LCBAS, requesting executive action for the completed technology-delivered questionnaire for FCS 4859.
- January 22, 2009 email from Associate Dean Lynch, CAH, requesting executive action to revise the prerequisite for SOS 3400* and change the course titles of HIS 3200, MUS 0200, and MUS 0233.

(Note: The revisions to the SOS 3400 prerequisites also appeared on the January 15, 2009 CAA agenda -- See Communications C.1 and C.2 from Dean Hanner, COS, and Dr. Coit, CAHCC Chair, on that agenda.)

After the meeting, Associate Dean Lynch noted that the request to revise the course title for MUS 0200 was submitted to CAA in error. As a result, it was withdrawn.

 Ms. Dilworth reported that the Senior Seminar Review Subcommittee will meet regularly on Fridays beginning January 30, 2009. Additional suggestions may be submitted to Dr. Les Hyder, Chair of the Senior Seminar Review Subcommittee.

1. 09-03, SOC 1838G, Introductory Sociology (Revised Course)

Dr. Foster and Dr. Hendrickson presented the proposal and answered questions of the council.

Ms. Dilworth moved and Dr. White seconded the motion to approve the proposal. The motion passed with the following vote:

The proposal was approved, effective Fall 2009.

Note: SOC 1838G will delete and replace SOC 2710G. Also, it will be placed under the Social and Behavioral Sciences segment of General Education and given the cultural diversity designation.

1838G SOC Introductory Sociology. (3-0-3) S. Scientific description of the regularities and patterns of behavior that characterize our society and the larger global environment. Sociological analyses of the social forces that affect our daily lives. Course may not be repeated.

2. 09-04, SOC 2000, Sociology Professional Seminar (New Course)

Dr. Foster and Dr. Hendrickson presented the proposal and answered questions of the council. The council requested revisions to the proposal.

Ms. Dilworth moved and Dr. White seconded the motion to approve the proposal. The motion passed unanimously.

The proposal, with revisions, was approved, effective Fall 2009.

2000 SOC Sociology Professional Seminar (1-0-1) F, S. (Credit/No Credit) This seminar is designed to familiarize departmental majors and minors to the field in general and opportunities and challenges both in continued education and in the labor force. Prerequisite: SOC 1838G. Course may not be repeated.

3. 09-05, SOC 3050, Sociological Theory (New Course)

Dr. Foster and Dr. Hendrickson presented the proposal and answered questions of the council. The council requested revisions to the proposal.

Dr. Hyder moved and Ms. Alexander seconded the motion to approve the proposal. The motion passed with the following vote:

The proposal, with revisions, was approved, effective Fall 2009.

Note: The course will delete and replace SOC 2850 and SOC 3250.

3050 SOC Sociological Theory. (3-0-3) F, S. A study of sociological theory from the classical founders through contemporary dialogue in the discipline. Special focus will be placed on major systems of sociological thought, primary contributors to the field, and possible applications of sociological theory to social phenomena. Prerequisite: SOC 1838G. Course may not be repeated.

4. 09-06, Sociology Major (Revised Major)

Dr. Foster and Dr. Hendrickson presented the proposal and answered questions of the council. The council requested one revision to the proposal.

Dr. Sterling moved and Ms. Dilworth seconded the motion to approve the proposal. The motion passed unanimously.

The proposal (See Attachment A), with one revision, was approved, effective Fall 2009.

5. 09-07, Sociology Minor (Revised Minor)

Dr. Foster and Dr. Hendrickson presented the proposal and answered questions of the council.

Ms. Alexander moved and Dr. Campbell seconded the motion to approve the proposal. The motion passed unanimously.

The proposal (See Attachment B) was approved, effective Fall 2009.

Effective Fall 2009

1. Add GPA requirements to the SOS 3400 course prerequisites.

3400 SOS Methods and Materials in the Social Studies in the Secondary School. (3-1-3) F, S. Aims and goals of social studies teaching; nature and scope of social studies materials; methods used in teaching the social studies, including those employing instructional technology. Thirty clock hours in clinical experiences are required. This course is designed to meet the needs of students who will receive Social Science Teaching Certification. Prerequisites: SED 3330 and EDP 3331; for ISEP students, SED 3000 and SED 3100; for Middle Level Education majors, MLE 3110. For students under catalogs prior to fall 2008, a major grade point average of 2.75 and a cumulative grade point average of 2.75; for students under catalogs from fall 2008 and later, a 3.00 major grade point average and a 2.75 cumulative grade point average. These requirements are effective fall 2009.

3200 HIS Islamic History. (3-0-3) On Demand. The conquests, law and customs, art and sciences of the Moslem world, including Spain, Persia, the Turks, and the Sudan. WI, NUS3

0233 MUS Chamber Singers Camerata. (0-2-1) A select choral ensemble that performs madrigals and other choral literature appropriate for a chamber choir. Prerequisite: Audition or permission of the instructor.

3960 NSE National Student Exchange, Plan A. (15-0-15 -12 to 18) F, S. Enrollment in a National Student Exchange member institution. Student pays tuition to the host campus. Approval of the campus NSE Coordinator is required. Prerequisite: Students must have completed 12 hours of coursework at EIU with a GPA of 2.5 or higher. Equivalent course: NSE 3990. Course may be repeated a maximum of two times.

2. Revise the credit hours for NSE 3961.

3961 NSE National Student Exchange, Plan B. (15-0-15 -12 to 18) F. S. Enrollment in a National Student Exchange member institution. Student pays tuition and fees to EIU. Approval of NSE Coordinator is required. Prerequisites: Students must have completed 12 hours of coursework at EIU with a GPA of 2.5 or higher. Equivalent Course: NSE 3991. Course may be repeated a maximum of two times.

3. Update the credit hours for NSE 3990.

3990 NSE National Student Exchange Plan A, Honors. (15-0-15 -12 to 18) F, S. Enrollment in a National Student Exchange member institution. Student pays tuition to the host campus. Approval of the campus NSE Coordinator is required. Prerequisites: Student must have completed 12 hours of coursework at EIU with a GPA of 3.0 or better. Admission to the Honors College required. Equivalent Course: NSE 3960. Course may be repeated a maximum of two times.

4. Adjust the credit hours for NSE 3991.

3991 NSE National Student Exchange Plan B, Honors. (15-0-15 -12 to 18) F, S. Enrollment in a National Student Exchange member institution. Student pays tuition and fees to EIU. Approval of the campus NSE Coordinator is required. Prerequisites: Students must have completed 12 hours of coursework at EIU with a GPA of 3.0 or higher. Admission to the Honors College required. Equivalent Course: NSE 3961. Course may be repeated a maximum of two times.

(exclusive of 4275) chosen in consultation with the student's advisor. To be certified for graduation with a major in sociology, a student must achieve a CGPA of at least 2.0 in the core courses in the major used to satisfy graduation requirements.¹

(Major GPA based on Anthropology 2200G if taken at EIU and all sociology courses taken at EIU.)

¹If the student believes there are extenuating circumstances relevant to the failure to meet this requirement, filing an appeal to the Departmental Grade Appeals Committee is possible

If foreign language is exempt, 45 hours of free electives are available and provide the opportunity for the student to complete one or more minors or even selective majors, all within the four years.

AND

15 semester hours of electives in Sociology (exclusive of 4275 and 3970), of which at least 9 hours must be courses numbered 3000 or above, selected in consultation with a Sociology advisor of the student's choosing.
