- B. Faculty Forum: 1 February 2005, in the University Ballroom. Additional reminders will be mailed to all faculty and electronic reminders will be sent prior to the Faculty Forum. The four components of the forum will have the following moderators and recorders:
  - 1. Level of Academic Challenge: Senator Fischer (moderator) and Senator Wolski (recorder)
  - 2. Enriching the Educational Experience: Senator Stimac (moderator) and Senator Allison (recorder)
  - Student Interactions with Faculty: Senator Benedict (moderator) and Senator Kilgore (recorder)
  - 4. Encouraging Active Learning: D. Muffler (moderator) and Senator Pommier (recorder).
- C. Child care at Eastern Illinois University: Senator Pommier informed the Senate that additional data will collected and that he will ask Chairs for help asking their faculty. Dean Hine stated that this issue

is a powerful opportunity to increase the growth of on campus and off campus student enrollments. He volunteered he help in the survey. Senator Allison stated that A. Zahlan informed him that the cooperative possibility of a child care center sounded like a great idea.

#### VI. New Business

- A. Senator Fischer asked that since the BOT is now complete, should the Faculty Senate invite them to one of the meetings. Chair Carpenter stated that he would forward the open invitation to attend any of the Faculty Senate meetings.
- B. Senator Fischer asked Chair Carpenter if he knew if Dean Irwin was planning to attend a Faculty Senate meeting in the future. Chair Carpenter replied that he did not, but did understand that Dean Irwin was hoping to inform the Senate about possible changes being made. Senator Allison stated that he hoped to know of changes before they were implemented.
- C. Senator Kilgore asked about crimes on campus. Chair Carpenter stated that he would invite Chief Due to Faculty Senate at some future meeting.
- D. Senator Fischer stated that he would like to have a discussion on the future of Eastern Illinois University, i.e., where Eastern Illinois University will be in five ten years and what it, and our students, will look like. Senator Benedict added that addressing enrollment in terms of optimal enrollments would be a good addition to the discussion. Senator Kilgore asked if summer term enrollments have been decreasing. VPAA Lord stated that summer session enrollments are down slightly from last year at this time, but that is probably related to a decrease in interest. Lord added that projections are for summer enrollment to increase over the next two or three years as the number of students planning graduation increase. Senator Kilgore asked if summer study abroad is growing. Lord replied that it is and new programs are being added.
- E. Senator Ogbomo suggested that a discussion concerning room/space problems be addressed. There are faculty sharing office space, which in turn leads to motivation and retention issues. VPAA Lord stated that Eastern Illinois University is space especially challenged right now with an increased enrollment and having lost the use of two buildings (Blair Hall and the Doudna Fine Arts Building).
