PROPOSAL FOR REVISION IN FCS IN BUSINESS OPTION

Jean Dilworth presented revision of this option. The proposal changes the title from FCS in Business Option to Apparel & Textiles, Consumer Studies, Hospitality, Merchandising Option. The new Apparel & Textile concentration within this option has a minor in Print and Textile Design Technologies built into it instead of the business minor that is built in the other three concentrations within the option. No changes are being proposed for the Consumer Studies, Hospitality, and Merchandising concentrations.
