Council on Academic Affairs Minutes

January 13, 2005

The January 13, 2005 meeting of the Council on Academic Affairs was held at 2:01 p.m. in Booth Library Conference Room 4440.

Members present: Dr. Carwell, Dr. Dietz, Ms. Dilworth, Dr. Fewell, Dr. French, Dr. Methven, Ms. Miller, Mr. Muffler, Dr. Reid, Dr. Tidwell, and Dr. Upadhyay.

(Ms. Nicole Wroblewski's will not be serving on CAA as a student representative during the Spring 2005 Semester since she is no longer a member of the Student Government. The name of her replacement is not known at this time.

Also, Dr. Julie Dietz returns this semester after taking a sabbatical leave during the Fall 2004 Semester. Note: While Dr. Dietz was on sabbatical leave, Dr. Francine McGregor filled her position on CAA.)

Members absent: None.

Staff present: Dr. Lord and Ms. Fopay.

Guests present: Ms. Brigitte Dietz, visitor; Mr. Erick Dietz, visitor; Mr. John Henderson, Center for Academic Technology Support; Dr. Michael Hoadley, Center for Academic Technology Support; Mr. Glenn Hild, Art; and Ms. Betsy Miller, College of Arts & Humanities.

Dr. Tidwell welcomed Dr. Dietz back to CAA.

I. December 9, 2004 Minutes:

- a.) The minutes of December 9, 2004 were approved as amended.

On page five of the minutes, the Political Science executive action requests are incorrectly listed under the Lumpkin College of Business & Applied Sciences (LCBAS) pending executive action requests. Since the Department of Political Science is a department within the College of Sciences (COS), the executive action heading should read Pending Executive Actions, COS, Effective Fall 2005.

- b.) At the December 9, 2004 CAA meeting, Dr. Reid reported inconsistencies she found regarding how the College of Arts & Humanities and the Lumpkin College of Business & Applied Sciences handled waiver requests for HIS 2010 and 2020 (See 12/9/04 CAA Minutes -- Page 2, Communication # 7.) Dr. Tidwell reported today that he contacted the deans from both of these colleges regarding the concerns that Dr. Reid had expressed. He said that both deans decided that they would not approve waivers from those two courses as general

education. However, some exceptions might be made depending on the situation. The one that had been approved, he said, had been an exception.

Dr. Reid noted that the waiver appeals denied report states the reason for denying a student's waiver request to count HIS 2020 for humanities in general education is that the course did not meet the goals of general education. Dr. Reid had no objections to the waiver being denied. However, she indicated that report needed clarification since the course actually meets the goals of general education, but the course is not an authorized EIU general education course.

III. Committee Reports:

1. Dr. Tidwell explained that he and Dr. Reid met with the Council of Deans this week to discuss the draft of the CAA General Education Subcommittee's report on General Education Assessment and Refinement. Also, he said that during the week of January 24 both he and Dr. Reid will meet with all four of the college curriculum committees to discuss the report. He thought it would be the middle or end of February before the report could go before CAA for approval or disapproval. Once the item is approved by CAA, he indicated the council could then establish deadlines for departments to submit general education proposals. The idea, he said, would be for the council to act on all of the general education proposals as a package.

VI. Other Business:

1. Center for Academic Technology & Support's *Turnitin* Presentation.

Dr. Hoadley and Mr. Henderson gave a presentation on *Turnitin*. They explained that *Turnitin* is a Web-based anti-plagiarism service that can also be used as an educational tool to teach students how to correctly cite references. During the presentation they provided details and result from a pilot study conducted by the Center of Academic Technology Support (CATS) last spring of EIU instructors and students using the service.

Mr. Henderson gave a PowerPoint presentation that included details about the service, its purpose and benefits, and an example of how *Turnitin* checks papers for plagiarism and improperly cited references. He distributed two handouts. One was a copy of the example shown during the presentation. The other handout included information about the CATS *Turnitin* information Web site, the EIU *Turnitin* e-mail address, and a list of EIU *Turnitin* administrators including their phone numbers and e-mail addresses.

Finally, Dr. Hoadley and Mr. Henderson answered various questions that council members had about the service. Also, they explained how individuals could obtain a *Turnitin* account and who to contact for questions. Dr. Hoadley encouraged the council members to use the service for their classes. He indicated that one-on-one or group training could be setup for anyone interested in learning more about the service.

Dr. Upadhyay arrived at 2:40 p.m.

The next meeting will be held Thursday, January 20, 2005.

1. Change the course grading to Credit/No Credit and revise the course prerequisite for PLS 2211.

PLS 2211 - Techniques of United Nations Diplomacy

(1-0-1) S. **(Credit/No Credit)** A role-playing experience in which students represent selected countries at the Model United Nations designated by the department. The countries represented will vary from year to year. The course may be repeated for a total of three semester hours, but no more than two semester hours may count toward the Political Science major or the Political Science minor.

Prerequisites and Course Notes: Restricted to students selected to represent EIU at a Model United Nations designated by the department. Students **may pay expenses associated with registration**, travel, room and meal charges while attending the simulation.

Credits: 1

2. Change the course grading to Credit/No Credit and revise the course prerequisites for PLS 2512.

PLS 2512 - Mock Trial.

(1-Arr-1) F, S. **(Credit/No Credit)** A role-playing class in which students are trained to represent attorneys and witnesses in a mock trial competition.

Prerequisites and Course Notes: Permission of the chairperson of Pre-legal Studies Committee. The course may be repeated for a total of six semester hours, but no more than two semester hours may count toward the Political Science major or the Political Science minor. Students **may pay expenses associated with registration**, travel, room and meal charges while attending competition.

Credits: 1

3. Change the course grading to Credit/No Credit and revise the course description for PLS 2611.

PLS 2611 - Model Illinois Government.

(1-0-1) S. (Credit/No Credit) This course is designed to prepare students for the Model Illinois Government simulation held in Springfield. At the simulation, students take a hands-on approach to understanding the legal authority, structure, functions and processes of the state legislature in Illinois. The course may be repeated for a total of three semester hours, but no more than two semester hours may count toward the Political Science major or the Political Science minor. Students may pay expenses associated with registration, travel, room and meal charges while attending the simulation.

Prerequisites and Course Notes: Prerequisite: Restricted to students selected to represent EIU at the simulation.

Credits: 1

The Art Department is requesting the establishment of an Art History Minor; this would be a new minor.
