Council on Academic Affairs Electronic Meeting July 6-8, 2004 Minutes

The July 6-8, 2004 meeting of the Council on Academic Affairs was held electronically. The meeting began July 6. It ended when a quorum was reached on July 8, 2004.

Members participating: Dr. Bock, Dr. Dietz, Ms. Dilworth, Dr. Fewell, Dr. Helsel, Dr. Methven, Dr. Reid, and Dr. Tidwell.

I. Minutes

The minutes of April 29, 2004 were approved as written.

II. Communications:

1. April 23, 2004 and April 30, 2004 College of Sciences Curriculum Committee Meeting Minutes.
2. April 26, 2004 College of Education & Professional Studies Curriculum Committee Meeting Minutes.
3. May 3, 2004 and May 10, 2004 Lumpkin College of Business & Applied Sciences Curriculum Committee Meeting Minutes.
4. Academic Waiver Reports for April 2004 from the Lumpkin College of Business & Applied Sciences, College of Arts & Humanities, College of Education & Professional Studies, and College of Sciences.

Dr. Reid requested clarification as to why LCBAS denied waiver request 04-65. She indicated in her email to the council that "Anita Shelton approved the substitution of HIS 2560 for HIS 2300 for grade re-calculation. HIS 2300 no longer exists and HIS 2560 replaced it".

Also, Dr. Reid requested an explanation regarding waiver request 04-26 listed on the April CEPS Waiver Report. She wanted clarification "that the HIS 2020 accepted as a humanities credit for Gen. Ed. was earned somewhere other than EIU - Is it a transfer credit?"

In regards to waiver request CAH-04-168 listed on the April CAH Waiver Report, Dr. Reid wanted confirmation that 1581 is really MUS 1581.

Finally, regarding the April COS Waiver Report – Dr. Reid indicated that she wanted clarification regarding waiver request 04-49. In her email she indicated the following: "Does 90.133 have a preface to indicate department offering the course? And it can't waive the HIS 2010 Gen Ed. social science requirement at EIU because HIS 2010 is not a Gen Ed option. Would it be more accurate to accept 90.133 to satisfy a Gen. Ed. Social Science requirement and not mention HIS 2010?"

Dr. Methven will look into Dr. Reid's comments and questions.

5. May 3, 2004 memorandum from Dean Rohn, CEPS, requesting an executive action request to change the course title for REC 2250 to Principles of Therapeutic Recreation, effective Fall 2004.
6. May 27, 2004 email from Ms. Sue Harvey, Records Office, regarding AP Exams for European and World History.
7. June 1, 2004 email from Dr. Parker Melvin, Music, in which he provided a revised copy of the MUS 4861 course proposal that was revised at the request of CGS on May 4, 2004. *NOTE:* Prior to these revisions, CAA had approved the original proposal (CAA Agenda Item # 04-41) on April 22, 2004.
8. Academic Waiver Reports for May 2004 from the Lumpkin College of Business & Applied Sciences, College of Arts & Humanities, College of Education & Professional Studies, and College of Sciences.

Dr. Reid wanted to make sure that waiver request 04-79, listed under the waivers denied section of the May COS Waiver Report, had been resolved. She indicated the following: "The waiver to grant credit for HIS 1500G & HIS 4820 based on an AP World History test was initially denied, which prompted the policy change presented by Sue Harvey (Memo "AP Exams for European or World History" dated May 27, 2004)." Dr. Reid asked "So, has the student/will the student receive credit via the AP World or European History Exam? The policy change applies only to tests taken from Fall 2004."

Regarding the May CAH Waiver Report, Dr. Reid requested confirmation regarding two approved waivers. The first one, CAH-04-189, Dr. Reid wanted to know whether 1581 is really MUS 1581. The second one, CAH-04-193, she wanted to know whether 1308 is really MUS 1308 and that 1302 is really MUS 1302.

Dr. Methven will look into Dr. Reid's comments and questions.
