Minutes

April 29, 2004

The April 29, 2004 meeting of the Council on Academic Affairs was held at 2:03 p.m. in Booth Library Conference Room 4440.

Members present: Dr. Bock, Dr. Dietz, Ms. Dilworth, Mr. Donash, Dr. Fewell, Dr. Helsel, Dr. Methven, Dr. Reid, Ms. Samuels, Ms. Sartore, Ms. Sterling, and Dr. Tidwell.

Staff present: Dr. Lord, Dr. Herrington-Perry, and Ms. Fopay.

Guests present: Dr. Borzi, Speech Communication; Dr. DePetro, Philosophy; Ms. Gartley, Records Office; Dean Johnson, College of Arts & Humanities; Ms. Miller, Political Science; and Mr. Netiuk, *Daily Eastern News*.

I. Minutes

The minutes of April 22, 2004 were approved as written.

II. Communications:

1. April 22, 2004 Lumpkin College of Business & Applied Sciences Curriculum Committee Meeting Minutes.
2. April 26, 2004 memorandum from Dean Hanner, COS, executive action requests to add a prerequisite to PLS 2611, effective Spring 2005, and to designate PSY 4270 as writing-intensive, effective Spring 2004.
3. April 26, 2004 memorandum from Dr. Herrington-Perry, Assistant Vice President for Academic Affairs, requesting CAA to appoint a representative to the Enrollment Management Advisory Committee (EMAC) for the AY 2004-05.
Ms. Dilworth agreed to continue to serve as the CAA representative to the Enrollment Management Advisory Committee. Dr. Tidwell moved and Dr. Bock seconded the motion to accept Ms. Dilworth as the representative.
4. Summer CAA Meeting Dates.
The council discussed possible dates that the members could meet during the summer. The group came to a consensus that a meeting could be held during the first part of July. The following are possible meeting dates that were established: July 6, July 7, or July 8, 2004.

Dr. Methven indicated that the council members would be notified if and when a meeting needed to be held.

III. Committee Reports:

1. Dr. Fewell indicated that the Academic Technology Advisory Committee (ATAC) met and discussed open labs and how the labs will be funded and the equipment in the labs replaced. She explained that the group plans to discuss the criteria for open labs at its next meeting. In addition to Dr. Fewell's comments, Provost Lord and Dr. Tidwell provided supplementary details regarding the ATAC meeting.
2. Dr. Reid indicated that she had attended the interviews for the Honors College Dean's position.

IV. New Business:

1. Provost Lord brought the council up-to-date on the happenings following the Blair Hall fire. He mentioned that all of the Blair Hall employees have been relocated to different buildings on campus. The majority of the individuals will be housed in the former Clinical Services Building. Those departments include the African-American Studies, Graduate School,

Grants & Research, International Programs, Legal Counsel, and the Sociology/Anthropology Department. School of Education employees will be located in the Buzzard House and Minority Affairs employees on the fourth floor of Booth Library.

He indicated that first floor of Blair Hall was largely intact. The second floor had more damage, but a large amount of the items can be retrieved. Unfortunately, most of the third floor of the building is not recoverable.

The University will contact a company who can freeze dry materials and hopefully restore many of the items. If a structural engineer deems the building structural sound, individuals may be allowed back into the building to retrieve material as long as they are admitted with guides.

Twelve Sociology/Anthropology faculty offices had been located on the third floor of the building and a great deal of their material was lost in the fire, some of which included administrative records, professional libraries and student records. Provost Lord explained that he met with the Sociology/Anthropology faculty members to discuss what could be done. One of the main concerns was grading. Luckily, some information can be retrieved from WebCT. Unfortunately, other information was stored only in grade books. Provost Lord indicated that several options were laid out to the instructors. Each faculty members will assess their situation and communicate with their department chair to establish consistent guidelines for grading students.

Finally, several students lost books and materials in the fire. He requested that faculty members take this into consideration as students prepare for finals.

2. 04-44, PHI 3500, Metaphysics (New Course)

Dr. DePetro presented the proposal and answered questions of the council. The council requested that following revision to 2.b. of the course proposal be made.

PHI 3500. Metaphysics. (3-0-3) S-odd-numbered years. Metaphysics. This course is an examination of contemporary analytical metaphysics: topics include the nature of truth, identity (including personal identity), possible worlds, material constitution and freedom of the will. Prerequisites: Three semester hours in philosophy or permission of the instructor. WI

3. 04-45, PHI 3720, Theory of Knowledge (Revised Course)

Dr. Depetro presented the proposal and answered questions of the council. The council requested that following revision to 2.b. of the course proposal be made.

PHI 3720. Theory of Knowledge (3-0-3) F-odd-numbered years. Thry Knowledge. This course is an examination of contemporary epistemology: topics include the nature of rationality, truth, an analysis of knowledge, and a study of the sources of human knowledge. Prerequisite: Three semester hours in philosophy or permission of the instructor. WI

4. 04-46, Philosophy (Program Revision)

Dr. Depetro presented the proposal and answered questions of the council. The motion passed unanimously.

The proposal (**See Attachment A**) was approved, effective Fall 2004.

Dr. Bock and Ms. Dilworth left the meeting at 3:00 p.m.

2611 PLS. Model Illinois Government. (1-0-1) S. This course is designed to prepare students for the Model Illinois Government simulation held in Springfield. At the simulation, students take a hands-on approach to understanding the legal authority, structure, functions and processes of the state legislature in Illinois. The course may be repeated for a total of three semester hours, but no more than two semester hours may count toward the Political Science major or the Political Science minor. Students pay travel, room and meal charges while attending the simulation. **Prerequisite: Restricted to students selected to represent EIU at the simulation.**

The Philosophy major comprises one general education course in Philosophy; PHI 1900G, 4480; History Component: PHI 2000 and 3260; Value component: at least one of PHI ~~3010~~, 3020, 3030, 3040, 3050G, ~~3060~~. Theory of Knowledge Component: at least one of PHI 3700G, 3720, ~~3740~~, 3780; Language Component; a student must complete either Option A (one year of foreign language at the college level) or Option B (PHI 3900); and ~~15~~ hrs. of PHI electives.

PHI 3010 – Medical Ethics - This is a catalog typo. The department eliminated this course years ago; it is no longer listed in the catalog

PHI 3060 – Philosophical Ideas in Literature – This course is currently being eliminated by executive action.

PHI 3740 – Philosophy of Mind – This course is changing number to PHI 3540 and will be offered as part of the Metaphysics Component.

The PHI electives will be reduced to 9 as a result of the program changes.

The Philosophy major comprises one general education course in Philosophy; PHI 1900G, 4480; History Component: PHI 2000 and 3260; Value component: at least one of PHI 3020, 3030, 3040, 3050G, **3070 (Philosophy of Law)**; Theory of Knowledge Component: at least one of PHI 3700G, 3720, 3780; Language Component; a student must complete either Option A (one year of foreign language at the college level) or Option B (PHI 3900); **Eastern Philosophy Requirement: at least one of PHI 2010, 3310, 3320, 3680; Metaphysics Component: at least one of PHI 3500, 3540, 3520;** and **9** hrs. of PHI electives.
