**I. Minutes**

**II. Communications:**

1. February 10, 2003 memorandum from Dean Hoadley, Lumpkin College of Business and Applied Sciences, requesting executive action for FIN 2710.
2. February 10, 2003 memorandum from Dean Hoadley, Lumpkin College of Business and Applied Sciences, requesting executive action for ACC 4750, FIN 4820, MGT/INT 4800, and MGT 4950.
3. February 13, 2003 memorandum from Dean Hanner, College of Sciences, requesting executive action for PSY 2610, PSY 3805, and PSY 4610. Note that the Executive Action from PSY was revised, as noted below.

1. 03-20, HST 4770, Health Services Administration (revised course proposal)

Dr. Dietz presented the proposal and answered questions of the council. The motion passed unanimously.

**HST 4770, Health Services Administration (3-0-3) F, S Hlth Svcs Admin  
Examination of the health service sector applications of administrative and management concepts, including social administration, biomedical and business ethics, and management theory. Prerequisites: HST 2250, 2270, and 3750 or permission of the instructor. WI**

2. 03-21, EIU 4126G, Body, Health, and Society (new course proposal)

Dr. Dietz presented the proposal and answered questions of the council. The motion passed unanimously.

This agenda items is approved, *effective Fall 2003*:

**4126G Body, Health, and Society (3-0-3) F, S Body & Health An exploration of the interdisciplinary field of body studies, with an emphasis on the health impact of gender, ethnic, class, aging, and sexual orientation images in contemporary society. 75 hours completed. Health Studies majors are excluded.**

3. 03-19, Bylaws of the Council on Academic Affairs (revision)

*Dr. Dietz exited during the middle of this discussion.*

Considerable discussion ensued over the proposed revisions, including those that would 1) change CAA’s membership from at-large to academic college representation. (Suggested alternatives included retaining wholly at-large membership; adding at least 1 at-large member to the proposed configuration; and selecting one member from each academic college while retaining 5 at-large members.) 2) limit CAA chair eligibility; and 3) reduce CAA’s quorum from 8 to 6. Discussion will continue at the next meeting. It is anticipated that a vote will be taken on item 03-19 at that time.
