2. 02-50, SOS 3400, Methods and Materials in the Social Studies in the Secondary School (revised course)

Dr. Titus presented the proposal and answered questions of the council. The motion passed unanimously.

Family and Consumer Sciences majors complete 12 weeks of student teaching for 12 semester hours of credit. Special Education majors, Early Childhood Education majors, and Early Childhood Education majors with dual certification in Elementary Education complete 16 weeks of student teaching for 16 semester hours of credit. See your major department for specific requirements. **Effective Fall 2004, student teaching may not commence**

until passing scores in the Illinois Content Area Test, specific to the major, are verified. Credit for student teaching is earned by successful completion of the student teaching experience and completion of all departmental requirements which may apply.
