November 21, 2002

The November 21, 2002 meeting of the Council on Academic Affairs was held at 2:00 p.m. in the Martinsville Room.

I. Minutes:

The minutes of November 14, 2002 were approved as written.

II. Communications:

1. November 11, 2002 memorandum from Dean Mary Anne Hanner, College of Sciences, requesting executive action regarding course description changes for the following: BIO 4275, Biological Sciences concentrations, BIO 4984, Economics major, ECN 4594, and ECN 4596.
2. November 7, 2002 memorandum from Dean Diane Hoadley, Lumpkin College of Business and Applied Sciences, requesting executive action regarding FIN 4820, FCS 4230/5230, Dietetics Option, FCS 4300, and FCS-Option in Family and Consumer Sciences in Business.

EDU 4550, Alternative Certification: Introduction to Teaching (1-1-1) SU. ALT CERT INTRO. This course addresses Illinois Professional Teaching Standards in collaborative relationships and reflection and personal growth. The course is an introduction to the academically rigorous, intensive Alternative Certification Program. Requires 30 clock hours of participation/observation online. Prerequisites: Bachelor's Degree and proficiency with web browser software and Internet use.

Mr. Donnelly exited the meeting at this time.

Mr. Kestner presented the proposal and answered questions of the council. The motion passed unanimously. This agenda item is approved as revised, effective Fall 2003:

EDU 4560, Alternative Certification: Internship, Part I. (Arr. -Arr -6) F. ALT CERT INT I. This course is the first semester of a 2-semester internship. The course is a required component of the academically rigorous, intensive Alternative Certification Program. Prerequisite: Grade of "B" or better in EDU 4550, EDU 4551, EDU 4552, and EDU 4553.

This agenda item is approved as revised effective Spring 2004.

EDU 4561, Alternative Certification: Internship, Part II. (Arr. -Arr -6) S. ALT CERT INT II. This course is the second semester of a 2-semester internship. The course is a required component of the academically rigorous, intensive Alternative Certification Program. Prerequisite: Successful completion of EDU 4560.

Biological Sciences concentrations, Biology concentration: Add BIO 4275 as an excluded course, so the catalog will read *“Course work in the following areas: BIO 3510 or BIO 3520 and 26 sh of course work in the Biological Sciences (with the exception of BIO 3400, 4275, workshops, and courses designed for General Education except BIO 3002G) or Mathematics or Physical Sciences courses above 2000 (with the exception of general education and CHM 2310). A minimum of 20 sh must be taken in the Biological Sciences.*

Biological Sciences major (B.S.), Botanical Sciences concentration: Add the following phrase to the end of the list of concentration requirements: *“Excluding BIO 4275; so the catalog will read “Course work in the following areas: BIO 3300, BIO 3510, BIO 3610, BIO 3612, BIO 3614, BIO 4948 and 10 sh of course work from the following: BIO 2320, 2322, 3312, 3322, 3450, 3451, 4400, 4800, 4810, 4892, 4940, 4942, 4944, 4946, 4960, 4962. Excluding BIO 4275”*

Biological Sciences major (B.S.), Ecology and Systematics concentration: Add the following phrase to the end of the list of concentration requirements: "Excluding BIO 4275", so the catalog will read "*Course work in the following areas:* BIO 3510 or BIO 3520 and 26 sh of course work from the following: BIO 3300, 3322, 3450, 3415, 3700, 3720, 3810, 3950, 3952, 4400, 4800, 4810, 4812, 4814, 4816, 4818, 4832, 4940, 4942, 4944, 4946, 4948, 4950, 4952, 4954, 4956. Excluding BIO 4275."

Biological Sciences major (B.S.), Ecology and Systematics concentration: Add the following phrase to the end of the list of concentration requirements: "Excluding BIO 4275", so the catalog will read "*Course work in the following areas:* CHM 3300 or 3450, BIO 3100, BIO 3101, BIO 3300, BIO 3510² or BIO 3520², BIO 2200³ or BIO 3614³ or BIO 3620³ or BIO 3622³ and 11 sh of course work from the following: BIO 2200, 3210, 3450, 3451 3510, 3520, 3614, 3620, 3622, 3624, 4400, 4751, 4800, 4820, 4830, 4832, 4834, 4836, CHM 3455, 3460, 4790, 4860. Excluding BIO 4275."

Change prerequisite for BIO 4984 as follows: BIO 1200G, 1300G, 3200, and senior-level standing.

Change Admission requirements for Economics major (B.A.) as follows:

Admission to the program requires a 2.25 GPA in Economics course work with a least six semester hours of Economics earned.

Change the following Academic Program Requirement Description:

Areas of Concentration within the Option in Family and Consumer Sciences in Business.

From: Students in the FCS in Business option select an area of concentration consisting of courses taken in addition to the General Education requirement and Major Requirements. Each of the three areas of concentration is planned to supplement the student's professional goals and must be completed in consultation with the student's advisor. The area of concentration requirement and opportunities for choices are as follows:

To: Students in the FCS in Business Option select one of three concentrations: Consumer Affairs, Hospitality Management, or Merchandising. The FCS in Business Option includes the business administration minor courses. The area of concentration requirements follow:
