#### IV. <u>01-22, ENG 2001, Creative Writing: Nonfiction, New Course.</u>

Dr. Ringuette and Dr. Irwin presented the proposal and answered questions of the Council. The motion passed with a vote as follows:

This action approves the following to become effective Spring 2002:

ENG 2001. Creative Writing: Nonfiction. (3-0-3) S. CREAT WRIT NONF. A creative writing course focusing on the essay. Extensive reading, aimed at developing a critical vocabulary and background knowledge of the genre, will be integrated with extensive writing and workshop discussions. (Writing-centered.) Prerequisites: English 1001G and English 1002G.

#### V. <u>01-23, Creative Writing Minor, Proposed Revision.</u>

Dr. Ringuette and Dr. Irwin presented the proposal and answered questions of the Council. The motion passed with a vote as follows:

Note: Students are expected to select courses in consultation with a member of the Creative Writing staff, and English majors are required to take at least on course outside the English Department.

Note: Students are encouraged to take additional hours from the elective list as their schedules permit.
