MINUTES OF COUNCIL ON ACADEMIC AFFAIRS  
April 14, 1960

The Council on Academic Affairs held its seventeenth meeting at 10 a.m., April 14, 1960, in the Blair Hall Lounge--B207.

Members present were: Mr. Damann, Mr. Giffin, Mr. Heath, Mr. Landis, Miss Reinhardt, Mr. Rommel, Miss Smith, Mr. Tingley, ex-officio member Mr. Heller. Mr. Lefler and Mr. Manbeck were absent.

- I. The minutes of the last meeting were approved.
- II. No communications received since last meeting.
- III. General Requirements for B.S. and B.A. degrees.  
Further discussion. Mr. Heath moved that the President's proposals of January 14, as amended on April 6, with respect to the required number of hours for the B.S. and B.A. degrees be accepted. Mr. Tingley seconded the motion. Motion passed, with five votes in favor, three votes opposed.
- IV. Majors and Minors for B.S. and B.A. degrees.  
Mr. Tingley moved that the B. S. and B.A. degrees have a major of at least 48 quarter hours and a minor of at least 24 quarter hours. Mr. Rommel seconded the motion. Motion passed unanimously.
- V. Chemistry Department proposals.  
Mr. Foreman discussed the content and purpose of Physical Science 100, 101, 102, and the problem of tailoring the courses for different majors.  
The meeting adjourned at 11:50 a.m.
