MINUTES OF COUNCIL ON ACADEMIC AFFAIRS September 22, 1960

The Council on Academic Affairs held its first meeting of the academic server 1960-61 at 10 a.m., September 22, 1960 in Blair Hall - B207.

IV. Election of Chairman.
