

A - English Major for the B. A. and B. S. Degrees.

In addition to the general university requirements, the major includes:

- 1 History 343, 344.
- 2 The language requirement shall be restricted to one of the following: French, German, Latin, Spanish, Russian.
- 3 English 245, 246, 247, 250, 251, English 326 or 327. Six electives in English literature or American literature.
- B English Minor for the B. A. and B. S. Degrees.
  - I English 245, 246, 247, English 326 or 327.
    Two upper division courses in English literature or American literature.

### III. Pre-Law Program.

Mr. Rommel moved and Mr. Masley seconded the motion that the Pre-Law curriculum presented by the Social Science Department be approved. The motion passed unanimously.

IV. Education Department Proposal.
