Proceedings of October 19, 1970

The Proceedings of October 12 were approved as published.

REPORTS:

- A. Mr. Gover reported that the minutes of the Council of University Planning meeting of October 7, which were distributed, covered the business transacted at the meeting.
- B. Mr. Lenihan reported that the C. I. O. met on Thursday, but that minutes of the meeting were not yet available. The matters discussed at the meeting included advisement procedures, reducing the number of degrees offered, and the extension program. No decisions were reached on any of the matters discussed. It was the consensus that changing the remuneration for extension teaching from extra pay to released time would kill the extension program.
- C. Mr. Tingley reported on the activities of the Presidential Search Committee. A memo from Mr. Williams stated that Samuel Taber had been selected as the representative of the professional administrators. The students elected Bob Perry and Sue Campbell as their representatives. Ray Pranske, Jack Shook, and John Metcalf were appointed as ex-officio student members. The October 29 meeting with the Board Presidential Search Committee will be in the Heritage Room of the University Union instead of in the Walnut Room as previously announced.
- D. Mr. Whitlow reported that all the people appointed to minor committees by vote of the Senate on September 28 have accepted their appointments. A list is attached. Mr. Whitlow and Mr. Downs will bring in a report on Alumni Committee for action soon. There are several vacancies on Student-Faculty Boards. He solicits suggestions of people interested in the following positions: 1 member - Lecture Series Board; 1 alternate - Safety and Traffic Board; 1 member, 1 alternate - Men's Athletic Board.

There was a memo from President Doudna recommending the establishment of an interview committee to interview candidates for all non-teaching positions other than those falling under the purview of the Personnel Committee. The Personnel Committee would interview only candidates for vice presidencies, deanships, and department heads. Teaching personnel would be interviewed by the Interview Committees for these positions as is presently done. He expressed a willingness to discuss the matter with the Executive Committee of the Senate.

Mr. Calvin Smith moved that the Executive Committee consult with the President on the exact nature of the Interview Committee and exact list of positions to be considered. He was seconded by Mr. Downs. The motion passed unanimously.

- E. Mr. Kluge gave a report for the Elections Committee. He wondered if we would have to designate the committee assignment of the alternate to the Council of Faculties, since if the Amendments to the Council of Faculties Constitution are adopted, the committee assignments will be made by the Council of Faculties instead of by the faculty at each institution. He said the Elections Committee would work out the details for holding an election on the Constitutional Amendments and the selection of an alternate.

Mr. Tingley agreed to find out how the three members on the Council of Faculties from each institution are distributed among the four committees.

- C. The Minutes of the Council on Faculty Research for October 6, 1970.
- D. A memorandum from President Doudna enclosing a draft of an official notice to appear on October 22 concerning student participation in matters relative to curriculum and faculty selection.
- E. A memorandum from Mr. Colbert about the Teacher Evaluation Program. He complained that he participated in the program last fall, but had never received the report. He said he sent two inquiries to the Student Chairman of the Evaluation Committee and had asked Vice President Moody to intercede in his behalf but had received no report.

Miss Brown said that she had sent another copy of the report to him through Campus Mail after receiving the inquiry from him and was unaware until today that he had not received the second copy of the report.

Mr. Lenihan moved that information concerning Student Evaluation be the subject of the Fall Meeting of the Faculty. He was seconded by Mr. Calvin Smith. The vote was 13 for and 1 abstention.

Mr. Gover moved and Miss Read seconded a motion for an executive session. The motion passed unanimously.
