BUSINESS AWARDS PRESENTED

CHARLESTON, IL--Forty-two Eastern Illinois University students have received awards from the University's Lumpkin College of Business.

Each year the College presents awards to business majors on the basis of character, scholastic achievement and interest in the field of business.

The College offers a variety of undergraduate majors leading to the Bachelor of Science in Business degree, as well as a graduate program culminating in the Master of Business Administration degree.

NOTE TO THE EDITOR (Times Courier): Five area residents have received awards. They include Douglas Cawthon, son of David and Diane Cawthon of Mattoon; and Thelma Childers, Sheryl Davidson, David Juriga, and Rashida Kadiani all of Charleston.

Cawthon is the recipient of three awards in accounting. The first award is the McGladrey and Pullen Accounting Award given to a junior who shows promise of distinction in the field of public accounting.

Cawthon's second award is the Jerome Rooke Accountancy Scholarship which is presented each year to the most outstanding major in the junior year. The student must have earned a minimum grade point average of 3.0 overall and 3.5 or better on a 4.0 scale in Accountancy 2150 and Accountancy 3030.

His third award is a Eunice W. Dougherty Scholarship Award. This is a cash award which is available to juniors in the College of Liberal Arts and Sciences and the Lumpkin College of Business. A cumulative grade point average of 3.85 or higher is needed to be eligible. Cawthon, a junior accounting major at Eastern in the spring semester, is a 1989 graduate of Mattoon High School.

Childers is the recipient of the Student Accounting Society-Outstanding Senior Award. This is an annual award given to the senior whose scholarship, effort, ad attitude promise success in the profession of accounting. Childers, a senior accounting and finance major in the spring semester, is a graduate of Mt. Carmel High School. She and her husband, Steve, have a daughter Ashley.

Davidson is the recipient of a Donald and Clara Alice Seaman Shawver Scholarship. This is awarded to a student who resides within the Central Illinois region and demonstrates scholastic ability and financial need. Sheryl, a senior human resources major in the spring semester is a 1984 graduate of Lanphier High School. She and her husband, Jeff, have a son, Jeremy.

Juriga is also a recipient of the Eunice W. Dougherty Scholarship Award. Juriga, a junior majoring in accounting in the spring semester, is a 1989 graduate of Charleston High School.

Kadiani is the recipient of the Delta Mu Delta--Sophomore Achievement Award. This award is given annually to the business administration major completing the sophomore year with the highest grade point average. During the spring semester she was a sophomore majoring in business and accounting.
