2. Student Faculty Relations - Wood; Dotzauer, Student Senate. Don Dotzauer presented the Senate with a copy of revised Student-Faculty board proposal. Many of the Senate's earlier recommendations were included. Among Student Senate recommendations were: a) Apportionment Board - 8 students, 3 faculty; IAB - 4 students, 5 faculty; all other boards - 4 students, 2 faculty. b) Spelling out board responsibilities, attendance policies, and reporting policies. c) Inclusion of Model U.N. Board in Communications Board, Campus pharmacy committee in Health Service Board.

Hamand moved, Pierson seconded the motion to accept the Student-Faculty Board changes as presented. Motion passed.

OLD BUSINESS

Working Paper for the Constitution - On page 1, two corrections should be made. Art. I, Sect. II, paragraph 2 should read "Any person whose assignments or responsibilities are such that application of this definition cannot be made immediately, or with respect to whom there arise any question of her/his inclusion in the faculty by reason of position held. . ." Paragraph 3 should read, "In making its decision the Senate shall be guided by the following philosophy. . ."

In the Senate Constitution, Article VI, Section 3 it should read: "A quorum of the Faculty Senate shall be ten members."

NEW BUSINESS

Screening Committees for the Vice President for Administration & Finance, Dean of Academic Development, Dean of Graduate School & Extended Degree Programs will be selected after Spring break.

CORRECTION - In addition to student comments regarding the late cancellation of classes on the night of March 8th and on Friday, March 17th, many faculty members also felt that decisions could have been made at an earlier time.

The meeting adjourned at 3:00 p.m.
