March 3, 1988

I. Minutes:

The Minutes of February 25, 1988 were approved with the following corrections:

II. Communications:

1. Minutes of the Curriculum Committee, College of Applied Sciences.

III. New Course Proposal, MUS 3075: Computer Programming for Musicians - (88-12).

Ms. Light moved and Dr. McGown seconded the motion to approve the proposal. Voting will be later.

IV. New Course, ENG 1999, Analysis of the Short Story - (88-9).

Dr. Lasky and Dr. Quivey presented the proposal and answered questions of the Council. The proposal was amended to show the following: 4.d. credit for the course will count toward the 120 semester hour total but will not count toward the Humanities Requirement. English majors or minors; 5.A. Community College course will not be adjudged equivalent to this course. The motion passed unanimously. The action approved the following course to be effective Summer 1988.

ENG 1999. Analysis of the Short Story (2-0-2)

Course Description: A course in the understanding and enjoyment of short fiction, with emphasis on reading and evaluating selected masterpieces in this genre. A significant portion will be devoted to written analysis of these works. Prerequisite: High school students who have completed the junior year in a recognized high school, who have twelve acceptable units, who rank in the upper 25% of their high school class, and who have the recommendation of their principal, may apply.

V. Proposed Course Revision, CDS 4770, Advanced Study in Language Disorders - (88-10).

Action postponed to a future date.

VI. Proposed Changes in the Speech Pathology and Audiology Major - (88-11).

Removed from agenda. Because this involves a teacher certification program, the Council on Teacher Education has jurisdiction.

VII. Chairperson Hockman informed the Council that Dr. David Maurer will address the Council concerning the work of the Committee on University Governance and Outcomes at the next meeting.
