OLD BUSINESS:

The Senate further discussed the "Report of the Subcommittee of the Council of Academic Affairs and the Faculty Senate with Representatives of the Student Senate on Drop-Add and Registration Problems" (see minutes of October 20, 1981).

The Senate approved one change in the report: #1 should read: "All graduate registration be done by mail during pre-registration, or at regular registration, or in the first meeting of night classes."

Hockman moved (seconded by Floyd) that the report as amended be approved. The motion was unanimously approved.

Several senators reported that the 24-hour delay in re-processing drops, a part of Dean Taber's proposal, has been strongly objected to by faculty campus-wide.

The meeting adjourned at 4:10 p.m.
