The run-off election will be held Wednesday, April 7, 8 to 5, in the Union. Absentee voting can be done Monday, April 5, 10 to 4, in Physical Science 439 (Sue Stoner's office).

Stoner moved, seconded by Goodrick, that the Senate accept the faculty election results. Motion carried.

The Elections Committee submitted:

The committee recommends that section B. Elections #5 be amended in the following manner:

delete the first sentence add two sentences

If the list of candidates is only twice the number of positions to be filled in each major committee, the candidate/candidates receiving the highest number of votes shall be considered elected.

If the number of candidates is more than twice the number of positions to be filled, then election shall require a simple majority of those voting.

If the number of candidates receiving a majority is insufficient to fill the positions, a run-off election shall be held for the unfilled positions.

In the run-off election, ballots shall list not more than twice as many candidates as there are positions still unfilled in each major committee. This list is to be the names of those not elected but with the highest number of votes next to those elected, except in the case of ties where all names will appear.

A list, in alphabetical order, of those elected and of candidates in the run-off election shall be distributed to the faculty not later than April 24.

Stoner moved, seconded by Goodrick, that the Senate approve the By-Laws. Motion carried.

#### EXECUTIVE SESSION:

Sutton moved, seconded by Sullivan, that the Senate go into executive session.

Then Sutton moved, seconded by Stoner, that the Senate come out of executive session.

#### NEW BUSINESS:

1. Smith moved, seconded by Sutton, the following:

The recent announcement in the <u>Eastern News</u> concerning the appointment of an additional assistant dean in the College of Arts and Sciences and subsequent discovery this new position was not advertised, or candidates screened and interviewed--accepted procedures followed under affirmative action--caused the Faculty Senate, in session March 23, 1982, to pass the following:

The Faculty Senate resolves and recommends to President Marvin that new and/or replacement administrative positions be advertised and recognized procedures of screening and interviewing be implemented in accord with Affirmative Action/Equal Employment Opportunity Guidelines. Further, the Faculty Senate recommends that the appointment of an additional administrative position in the College of A and S be suspended until all its ramifications are studied carefully by faculty and administrators.

2. Preston submitted the following:

Whereas the Faculty Senate has expressed its concern with the lack of faculty involvement and interest in Faculty Senate proceedings, and

Whereas the Faculty Senate has declared itself toothless and impotent, and

Whereas the Faculty Senate has thought itself ineffective in dealing with some administrators, and

Whereas the Faculty Senate has lost its stature as parent committee for the major university committees, and

Whereas the Union is now responsible for many of the previous functions of the Faculty Senate,

It seems clear that many hours of faculty time are devoted to an empty enterprise, therefore, I move that the Faculty Senate abolish and dissolve itself. Rooke seconded the motion.

After some discussion LeDuc moved, seconded by Goodrick, that the motion be tabled. Motion approved unanimously.

The meeting adjourned at 3:20. The next meeting of the Faculty Senate will be on Tuesday, April 6, at 2:00 p.m. in the Martins-ville Room.
