

- III. Course Deletion, LAS 2100, Ascent of Man, (89-33). The Council discussed the proposal. The motion passed unanimously. This action approves the following to become effective immediately. Delete LAS 2100, Ascent of Man.
- IV. Response of Afro-American Studies Committee to CAA Item Agenda 89-34, (89-35). Ms. Johnetta Jones proposed a three-hour course on cultural diversity and conflict resolution. Dr. Bates moved and Dr. Sutton seconded the motion to approve the proposal.
- v. Proposal for the Number of Hours in Each Element in the Integrated Core, (89-34).

The Council discussed Quantitative Reasoning and Problem Solving, Foundations of Civilizations, United States Constitution, Senior Seminar. Those sections were left as proposed. Voting will be later.

The Council began discussion on the Language section. Dr. Quivey, Chair, Department of English, spoke to the Council on behalf of the LAS Advisory Committee.

Dr. Shonk proposed an amendment to the Language section: Language 9 sh The requirement should be three courses: two in reading and writing and one in listening and speaking.

These courses should be graded A, B, C, N/C.

<sup>1</sup>Every course approved for the Core shall contain a specific writing component. The writing component should be appropriate to the course content and the methods of instruction used in the course.

Mrs. Schaeffer distributed a proposed General Education Course Proposal format to the Council for comments.

Effective date: Spring 1990.
- ENG 3608 course description -- Change to read as follows: ENG 3608. Modern Drama: 1945-present. (3-1-3)S. Such playwrights as Miller, Williams, Brecht, Beckett, Ionesco, Genet, Pinter, Albee, Baraka, Stoppard, Hansberry. Some opportunity for the performance of scenes. Prerequisite: English 1002. (Group 6). Effective date: Spring 1990.
