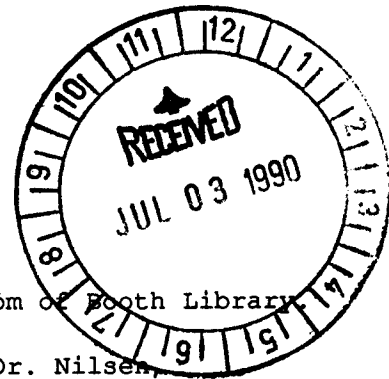

MINUTES OF THE COUNCIL ON ACADEMIC AFFAIRS  
June 28, 1990

I. Minutes.

The minutes of June 21, 1990, were approved as amended.

II. Communications.

College of Education Academic Waiver Report for the month of May.

III. New Course Proposal, LST 3XXX, Challenge of Leisure, (90-51-C), GEN ED - Human Behavior.

LST 3XXX, Challenge of Leisure. (3-0-3). F, S, SU. Chall/Leisure.

A study and evaluation of the effects of leisure on societies and individuals. Emphasis will be placed on an assessment of individual leisure participation throughout the life cycle. Prerequisite: None.

Dr. Nilsen moved and Dr. Sutton seconded the motion to approve the proposal. Voting will be later.

IV. New Course Proposal, HIS 1XXX, The U.S. Constitution and the Nation, (90-52-C), GEN ED - U.S. Constitution.

HIS 1XXX, The U.S. Constitution and the Nation. (3-0-3). F, S, SU. U.S.

Const. His. A survey of the origin and development of the Constitution and its impact on the history of the United States.

Dr. Shank moved and Mr. Herde seconded the motion to approve the proposal. Voting will be later.

V. New Course Proposal, PLS 1XXX, American Government and Constitution, (90-53-C), GEN ED - U.S. Constitution.

PLS 1XXX, American Government and Constitution. (3-0-3). F, S, SU. Gov. and Const.

The fundamental principles of the American constitutional system with appropriate comparisons to the Illinois Constitution: The founding fathers, the Constitution, civil liberties, the President, Congress, the judiciary, political parties, and electoral politics. No prerequisites.

Dr. Shonk moved and Dr. Gholson seconded the motion to approve the proposal. Voting will be later.

VI. New Course Proposal, MAT 3XXX, Mathematics and Problem Solving Applications, (and alternative), GEN ED - Quantitative Reasoning.

The Chair presented the Mathematics Department's request to withdraw the proposal. The motion was denied for lack of unanimous consent of the Council.

Mr. Bailey moved and Dr. Shank seconded the motion to table this item until the July 19, 1990 meeting. The motion passed with a vote as follows:

VII. Revised Course, ACC 2100, Principles of Accounting I, (90-34).

Dr. Walstrom and Dr. Wootton presented the proposal and answered questions of the Council. The motion passed unanimously. This action approves the following to become effective Fall 1990.

**ACC 2100, Principles of Accounting I. (3-0-3).**

A study of the financial accounting process and the accounting principles and procedures contained in financial statements. Topics include accounting processes for service and merchandising enterprises, current assets and liabilities and long-lived assets. Prerequisite: Completion of 30 semester hours or more.

VII. Revised Course Proposal, Principles of Accounting II, (90-35).

Dr. Walstrom and Dr. Wootton presented the proposal and answered questions of the Council. The motion passed unanimously. This action approves the following to become effective Fall 1990.

**ACC 2150, Principles of Accounting II. (3-0-3).**

This course is a continuation of Principles of Accounting I along with an introduction to managerial accounting. Topics include partnerships, corporations, long-term liabilities, statement of cash flows, C-V-P analysis, budgeting, manufacturing accounting, and standard cost. Prerequisites: ACC 2100 and completion of 30 semester hours or more.

VIII. Undergraduate Education Study of Eastern Illinois University, (88-99).

Dr. Breidenbach, Chair, Department of Foreign Languages, presented the proposals from the department for the foreign language segment, distributed corrections and answered questions of the Council. Discussion will continue on these proposals.
