Report of CAA Subcommittee to Devise a Course List for Cultural Diversity

The recommended list of courses below reflects the unanimous opinion of the subcommittee. Surprisingly, the subcommittee members, having made independent judgments in their review of some 100 courses submitted for the list, rarely disagreed in their views of individual courses. When a disagreement arose, discussion of a given course resulted in unanimous agreement quite quickly. The subcommittee was also very pleased to see the extent to which issues of cultural diversity are being addressed throughout the university. Virtually every course submitted for consideration by the departments did indeed include topics related to cultural diversity, to greater or lesser degrees. The subcommittee, however, accepted as its primary criterion the directive by Chair Sutton in his letter to the departments asking for courses which are "centrally concerned" with cultural diversity.

Courses submitted by the departments but not recommended for inclusion on this list are not to be considered as unworthy courses in themselves or as courses completely unrelated to cultural diversity. Some courses, for example, were not included because they were "special topics" courses, indicating that the content of the course does not remain constant and may diverge greatly from a cultural experience course in some semesters. Most other courses were excluded because they take up issues of cultural diversity only in a tangential fashion or in a manner in which cultural diversity becomes subordinate to other perspectives or concentrations. The subcommittee accepts that a concentration upon culture is essential to accomplish the goals of the requirement: to acquaint students with another culture as well as with their own and, by means of this acquaintance, to reduce tensions among the cultures.

An earlier CAA subcommittee on cultural diversity had determined that EIU students completing the new general education program will have satisfied the cultural diversity requirement by virtue of their having completed one of the Foundations of Civilization courses. Thus, all courses within the Foundations of Civilization segment have been included on this list.

The subcommittee unanimously recommends that the Council adopt the following list of courses from which students may choose to satisfy the cultural diversity requirement:
