III. New Course, ZOO 4760, Conservation Biology, (92-74).

Dr. Funk, Chair of Zoology, presented the proposal and answered questions of the Council. The motion passed with a vote as follows:

This action approves the following to become effective Fall 1993, pending CGS approval:

**ZOO 4760, Conservation Biology. (3-0-3). F. Conserv. Biology. Study of the application of ecological and genetic principles to the preservation and conservation of biological diversity. Topics will include the demography and genetics of small populations, population viability, island biogeography, and the design of nature reserves. Prerequisites: ZOO 3010 and LFS 3200.**

The above action deletes ZOO 4510, Microtechnique.

IV. New Course, MAT 4495, Undergraduate Research Experience in Mathematics, (92-75).

Dr. Rosenholtz, Chair of Mathematics, presented the proposal and answered questions of the Council. The motion passed unanimously.

This action approves the following to become effective Fall 1993:

**MAT 4495, Undergraduate Research Experience in Mathematics. (Arr.-Arr.-3). On Demand. Rsch Exp Math. An opportunity for a student to work one-on-one with a faculty member on a problem or topic of mutual interest, culminating in a substantial paper and an oral presentation. Prerequisites: Senior standing and permission of faculty member and department chairperson. Limited to Mathematics majors and Mathematics and Computer Science majors.**

V. CAA Review of the Major: Marketing, (92-58).

Dr. Sutton and Dr. Arnold, Chair of Marketing, presented the subcommittee report and answered questions of the Council. The motion to accept the subcommittee report and the initial report passed unanimously.

VI. CAA Review of the Major: Art, (92-56).

Dr. Hawker, Mr. Johnson - Chair of Art - Mr. DeRuitter, and Mr. Hild presented the subcommittee report and answered questions of the Council. The motion to accept the subcommittee report and the initial report passed unanimously.

EXECUTIVE OFFICER'S REPORT

October 27, 1992

The following items were approved by Executive Action to become effective Fall 1993:

1. MAT 1441C -- change prerequisite to read as follows: "Satisfactory Level III placement score or C or better in Mathematics 1300 and Mathematics 1330."
2. PHI 3780 -- change course offering from "F-odd-numbered years" to "S-even-numbered years."
3. PHI 3810 -- change course offering from "S-even-numbered years" to "F-odd-numbered years."

November 2, 1992

The following items were approved by Executive Action to become effective Fall 1993:

1. Deletion of CHM 2720, Principles of Quantitative Analysis, from the curriculum.
2. Catalog revisions of CHM 2730, Quantitative Analysis.
  - a. Change course offering from "F" to "F,S."
  - b. Change course description to the following:  
Theory and applications of gravimetric, volumetric, electrochemical, and spectrophotometric quantitative chemical analysis.  
Prerequisites: Chemistry (1410 and 1415) or (1510 and 1515).
3. Catalog revision of CHM 4644 Honors Thesis.  
Change course description to the following:  
Written thesis and oral presentation based upon a survey of the chemical literature and student's original research under close supervision of a chemistry honors faculty member. Required of students in the Departmental Honors Program. Prerequisites: A minimum of 2 credit hours of Chemistry 4555; admission to the Departmental Honors Program; permission of departmental honors coordinator, chairperson, and instructor.
