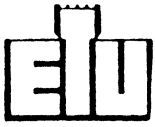

# Faculty Senate

Minutes of October 28, 1986

The meeting was called to order by Chairman Wohlrabe at 2:04 p.m. in the Martinsville Room of the MLK Union.

I. Wohlrabe dispensed with the regular agenda so that the students from The Association of International Students could speak to the Senate. The association consists of approximately eighty students. A major problem that the international students have is with the closing of the dormitories during school breaks. The enrollment of international students has slowly declined in recent years.

II. Chairperson Wohlrabe introduced the second speaker to the Senate. Anita Craig presented and discussed the sanctions placed against the Sorority/Fraternity that were involved with the recent student restraint. Of main interest was the sanctions regarding social functions.
