- III. Request to raise the English Language requirements for Undergraduate Admission of International Students from "Proficiency Level 8" to "Proficiency Level 9," (95-52).

IV. Request to change the name of the "School of Home Economics" to the "School of Family and Consumer Sciences" with a similar change in the name of the major, (95-47).

Dr. Joyce Crouse of Home Economics, and Dr. Martha Brown, Associate Dean of the Lumpkin College of Business and Applied Science, presented the proposed change and answered questions of the Council. The motion passed, as amended, unanimously.

This action approves the following to become effective Fall 1995, pending IBHE approval: Change name of the "School of Home Economics" to the "School of Family and Consumer Sciences." Change name of the <u>major</u> in "Home Economics" to <u>major</u> in "Family and Consumer Sciences."

V. Request to delete the Foods in Business concentration in Home Economics in Business Option, (95-48).

Dr. Joyce Crouse of Home Economics, and Dr. Martha Brown, Associate Dean of the Lumpkin College of Business and Applied Science, presented the proposed deletion and answered questions of the Council. The motion passed unanimously.

This action approves the following to become effective Fall 1995:

Delete the Foods in Business concentration in Home Economics in Business option.

VI. Revision of HEC 4140 to delete Food Service Sanitation certification, (95-49).

Dr. Joyce Crouse of Home Economics, and Dr. Martha Brown, Associate Dean of the Lumpkin College of Business and Applied Science, presented the proposed revision and answered questions of the Council. The motion passed unanimously:

This action approves the following to become effective Fall 1996:

HEC 4140, Institutional Food Management. (2-2-3). F,S. INST FOOD MGT. Practice in quantity food production; menu planning; recipe standardization; and management of time, motion and materials. Prerequisites: HEC 1120 and HEC 2472C.

VII. New Course, HEC 1121, Food Service Sanitation, (95-50).

Dr. Joyce Crouse of Home Economics, and Dr. Martha Brown, Associate Dean of the Lumpkin College of Business and Applied Science, presented the proposal and answered questions of the Council. The motion passed, as amended, unanimously:

This action approves the following to become effective Spring 1996:

HEC 1121, Food Service Sanitation. (1-0-1). F,S. FOOD SER SANI. Food production and food service sanitation and safety standards and regulations for food service operations including food storage, food handling practices and foodborne illnesses.

# VIII. New Course, HEC 4755, Nutrition for Physical Performance, (95-51).

Dr. Joyce Crouse of Home Economics, and Dr. Martha Brown, Associate Dean of the Lumpkin College of Business and Applied Science, presented the proposal and answered questions of the Council. The motion passed, as amended, unanimously:

This action approves the following to become effective Spring 1996, pending CGS approval:

HEC 4755, Nutrition for Physical Performance. (3-0-3). F,S. NUTR PHYS PERFM. Examination of metabolism and energy systems related to physical performance. Planning optimum diets for performance. Examine/evaluate controversial practices that may influence metabolism and performance. Prerequisites: HEC 2472C and ZOO 2001C.

IX. Proposed Commendation to Dr. Ruth Hoberman, Member of the Council on Academic Affairs.
Dr. Wohlstein moved and Dr. Midkiff seconded the following resolution, which was unanimously adopted, commending Dr. Ruth Hoberman for her work with the Council on Academic Affairs:
