GEL/INT 3300C, Science and Technology - A Promise or a Threat? (3-0-3) F,S,SU. SCIENCE AND TECH. Understanding science and technology, their impact in the advancement of societies and their social and cultural consequences. Papers, discussions, and extensive use of Internet are required.

VII. New Course, PLS 4863, Special Topics in Political Science, (96-19).

Dr. Andrew McNitt, Political Science, presented the proposal and answered questions of the Council. The motion passed unanimously.

This action approves the following to become effective Spring 1997, pending CGS approval:

PLS 4863, Special Topics in Political Science. (1-5-Arr.-3). Study of special topics in Political Science that are not ordinarily covered in existing courses. Topics to be announced. Study may include lecture, readings, oral presentations, group projects, and written assignments. May be repeated for credit on a different topic.

This course will replace PLS 4831, PLS 4832, and PLS 4833, Policy Practicum.
