Faculty Senate Vol. XIX-27 Minutes of April 17, 1990

The meeting was called to order by Tony Schaeffer at 2:06 P.M. in the Martinsville Room of the Martin Luther King Student Union.

The minutes of the previous meeting were unanimously approved.

II. Communications:

- A. Strategic Marketing Plan for the BOG System
- B. Minutes of the 4-6-90 meeting of the CAC
- C. Memo from Kandy Baumgardner, re: Faculty Senate elections

III. Old Business:

- A. Extensive discussion centered around faculty elections. On behalf of the Election Committee, Jorstad reported that over 425 ballots have been received; the committee recognizes that there could have been some problems with procedure, but all in all, we had a valid election. Despite isolated cases of faculty receiving two unmarked ballots (Clay-Méndez) and other inconsistencies, the numbers speak well for the process (Marlow). The Election Committee should be commended and the election should not be nullified by conjectural accusations, hearsay, and gossip (Sutliff). There is widespread disappointment with the procedures and other matters that are not based on hearsay, but factual data (Sylvia). A second election should be conducted, to allay the rumors about improprieties (Baumgardner). If a second election is held, it would have to be in attendance, as there is no time for a mail vote (Schaeffer). Motion was made (Sylvia/Clay-Méndez) that the Faculty Senate conduct a new election in attendance in the Martin Luther King Union. The vote was 4 yes, 4 no, and 5 abstained. Motion was made (Gosselin/Sutliff) that we keep elections as is and next week present and accept the results. The roll-call vote was: Carpenter (No), Clay-Méndez (No), Fewell (No), Gosselin (Yes), Goodrick (No), Leal (Yes), Marlow (Yes), Nordin (Yes), Schaeffer (Abstained), Sutliff (Yes), Sylvia (No), and Wallace (Yes). The motion carried.
 - B. Sutliff apologized for any confusion that the list he circulated may have caused.
- C. Discussion was held about the draft proposal on advertising on campus. Motion was made (Clay-Méndez/Wallace) to accept the proposal as presented, excluding any restrictions on advertisements in the <u>Daily Eastern News</u>. After further deliberation, it was moved (Gosselin/Marlow) to table the motion. Motion to table carried.
- D. Nordin reported on the Parking Committee recommendations for 1990-1991. Among these are the following:

Parking fees will increase by \$5.

- 2. Parking fines will increase from \$10. to \$20.; fire lane violations from \$25. to \$50; and parking in handicapped areas from \$25. to \$50. (all fines will be halved if paid within 48 hours).
- Work on O'Brien and North Stadium lots will be delayed and money saved will be spent on various other more pressing projects, such as increasing the parking area west of Lawson Hall by more than 175 spaces.
 - 4. Parking area between Coleman and Taylor halls will be for faculty only.
 - 5. There will be additional metered spaces near Booth Library.
- E. Gosselin reported on the Distinguished Faculty Awards. There have been nine completed files submitted, and all are very impressive. Names will be announced at a later date.

IV. New Business:

There was discussion concerning the BOG Strategic Marketing Plan. It appears to be a waste of \$250,000 and half of the contents could be thrown out (Schaeffer).

The meeting was adjourned at 3:36 P.M. The next Senate meeting will be April 24, at 2:00 P.M. in the Martinsville Room.
